WHEREAS, the Sangguniang Panlungsod received an endorsement letter from the City Mayor's Office (CMO) dated July 21, 2021 requesting for a supplemental appropriation for the supply and installation of firewall security appliance of the Sangguniang Panlungsod Office in the amount of One Hundred Fifty Seven Thousand Philippines Pesos (Php157,000.00) and for payment of prior year's obligation for the telephone bills of the Ormoc City Tourism Office in the amount of Eight Thousand Five Hundred Eighty Philippine Pesos and Twenty Six Centavos (Php8,580.26) for the total amount of One Hundred Sixty-Five Thousand Five Hundred Eighty Philippine Pesos and Twenty-Six Centavos (Php165,580.26);

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant, and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect LBP Form No. 8 and LBP Form No. 9 were consecutively issued by the concerned offices certifying therein that the amount of One Hundred Sixty-Five Thousand Five Hundred Eighty Philippine Pesos and Twenty-Six Centavos (Php 165,580.26) is deemed available for the aforementioned purpose, herein attached as Annex "A" and "B" respectively;

WHEREAS, this Sanggunian finds the supplemental request justified and deemed reasonable and meritorious and for the efficient execution of business operations and/or transactions of the aforementioned office hence, most deserving of prompt favorable action

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 025 (Series of 2021)

AN ORDINANCE APPROPRIATING THE CY 2020 UNAPPROPRIATED SURPLUS AMOUNTING TO ONE HUNDRED SIXTY-FIVE THOUSAND FIVE HUNDRED EIGHTY PHILIPPINE PESOS AND TWENTY-SIX CENTAVOS (PHP165,580.26) TO THE OFFICE OF THE SANGGUNIANG PANLUNGSOD ICT EQUIPMENT ACCOUNT FOR THE SUPPLY AND INSTALLATION OF FIREWALL SECURITY APPLIANCE IN THE AMOUNT OF ONE HUNDRED FIFTY-SEVEN THOUSAND PHILIPPINE PESOS (PHP 157,000.00) AND TO THE ORMOC CITY TOURISM TELEPHONE OFFICE EXPENSE ACCOUNT FOR THE PAYMENT OF PRIOR YEAR'S OBLIGATION FOR THE TELEPHONE BILLS IN THE AMOUNT OF EIGHT THOUSAND FIVE MUNDRED EIGHTY PHILIPPINE PESOS AND TWENTY SIX CENTAVOS (PHP8,580.26), THIS CITY.

SECTION 1. <u>CY 2021 GENERAL FUND SUPPLEMENTAL BUDGET.</u> The total sum of One Hundred Sixty-Five Thousand Five Hundred Eighty Philippine Pesos and Twenty-Six Centavos (Php165,580.26) to be taken from the CY 2020 Unappropriated Surplus is hereby appropriated to the office of the Sangguniang Panlungsod in the amount of One Hundred Fifty-Seven Thousand Philippines Pesos (Php157,000.00) for the supply and installation of firewall security appliance and to the office of the Ormoc City Tourism in the amount of Eight Thousand Five Hundred Eighty Philippine Pesos and Twenty-Six Centavos (Php8,580.26) for the payment of prior year's obligation for the telephone bills, this city.

SECTION 2. <u>EXFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
