WHEREAS, the Sanaguniang Panlungsod received an endorsement letter from the City Mayor's Office (CMO) dated October 5, 2021 requesting for a supplemental appropriation from the Reversion of Savings-PS Savings from vacant positions of various offices in the amount of Twenty-Four Million Three Hundred Eighteen Thousand Six Hundred Sixty-Seven Philippine Pesos (Php24,318,667.00) as additional appropriation of the Current Year's Budget for Public Employment Services Program (PESP);

WHEREAS, the PESP under the City Mayor's Office aims to provide public employment and intensive assistance to residents of Ormoc City;

APPROPRIATION ORDINANCE NO. 041 (Series of 2021)

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 36, SERIES OF 2021 INVOLVING THE AMOUNT OF TWENTY-FOUR MILLION THREE HUNDRED EIGHTEEN THOUSAND SIX HUNDRED SIXTY-SEVEN PHILIPPINE PESOS (PHP24,318,667.00) AS ADDITIONAL APPROPRIATION OF THE CURRENT YEAR'S BUDGET FOR PUBLIC EMPLOYMENT SERVICES PROGRAM (PESP).
