**PREFATORY STATEMENT**

WHEREAS, the Sangguniang Panlungsod received an urgent endorsement letter from the City Mayor's Office (CMO) dated December 24, 2021 requesting for a supplemental appropriation from the Savings- Underestimated Income of Ormoc Waterworks System Administration (ORWASA) in the total amount of Twenty Million Philippine Pesos (Php20,000,000.00);

Whereas, the supplemental appropriation is intended to fund the following projects:
