PREFATORY STATEMENT

Ormoc City's existing Ordinance prohibiting any person from taking a bath or washing in public artesian wells, public faucets, and the like is Ordinance No. 8 of the then Municipal Board of Ormoc City dated December 16, 1950, wherein the penalty for such violations is a fine ranging from ₱1.00 to ₱5.00 at the discretion of the court and in case of insolvency, to suffer an imprisonment at the rate of ₱2.50 per day.

At present, many are still doing these prohibited acts mentioned above, hence, this Sanggunian feels the need to amend the penalty to be imposed so as to strictly enforce said ordinance, and not to defeat its purpose.

FOREGOING PREMISES CONSIDERED, on motion of Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, jointly seconded by Councilors Claudio P. Larrazabal and Mariano Y. Corro; be it

RESOLVED, to enact:

ORDINANCE NO. 68

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 8 S. 1950 OTHERWISE KNOWN AS "AN ORDINANCE PROHIBITING ANY PERSON FROM TAKING A BATH OR WASHING IN PUBLIC ARTESIAN WELLS, PUBLIC FAUCETS AND THE LIKE".

BE IT ENACTED, by the Eighth Sangguniang Panlungsod ng Ormoc, in SESSION assembled:

SECTION 1. Amendment. - Section 2 of Ordinance No. 8 s. 1950 is hereby amended to read as follows:



"SECTION 2. - Any violation of this ordinance shall suffer the penalty as follows:

First Offense - A fine not less than ₱100.00, but not more than ₱200.00

Second Offense- A fine not less than ₱201.00, but not more than ₱500.00

Third Offense - A fine not less than ₱501.00, but not more than ₱1,000.00. And to suffer subsidiary imprisonment in case of insolvency.

Fourth Offense- Imprisonment of not less than One (1) month.

SECTION 2. REPEALING CLAUSE. - All Ordinances, rules and regulations, or parts thereof, in conflict with, or inconsistent with any provision of this ordinance, are hereby repealed, amended or modified accordingly.

SECTION 3. EFFECTIVITY. - This Ordinance shall take effect after it shall have been posted in at least two (2) conspicuous places in the City of Ormoc not later than five (5) days from its approval and published once in a newspaper of general circulation within the City of Ormoc.

ENACTED, February 24, 1999.

RESOLVED, FURTHER, to furnish copies of this Ordinance each to the Regional Trial Court in Cities, the Municipal Trial Court in Cities, the City Prosecutors' Office, the City Legal Officer, the City Treasurer, the Ormoc PNP Headquarters, at least three (3) copies be posted in Bulletin Boards at strategic places and others concerned, -all in Ormoc City.
