ANATORY NOTE YPI

t has been observed that there is a proliferation in the use of TRISIKADS as Public Utility Vehicle within the City of Ormoc thereby ceusing traffic congestion to our city streets as drivers of these TRISIBADS are not properly oriented regarding traffic rules and regulations for some of these drivers are even minors. In short, these TRISIKADS FEDICABS endanger the lives of its passengers, its driver and most of all the public if its continuous operation will remain unabated.

For these TRISIKADS/PEDICABS, rendering services to the riding public cannot justify that their existence or operation is legal since they were never given a go-signal by this Sanggunian to operate in the city streets; hence, their continued operation up to the present is illegal and therefore, must be stopped once and for all.

FOREGOING PREMISES considered, on motion of Councilor Eduardo P. Chairman Committee on Transportation and Communications duly Tan, seconded by Councilor Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass and enact:

ORDINANCE NO. 72 "

AN ORDINANCE REGULATING THE USE OF TRISIKADS/PEDICABS AS UTILITY VEHICLES WITHIN THE 29 BARANGAY PUBLIC DISTRICTS OF ORMOC CITY.

RE IT ORDAINED, by the Eighth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. It is the declared policy of the City Government of Ormoc that the safety of the riding public is given attention and must therefore be safeguarded and protected in every way possible.

SECTION 2. As used herein, the following terms shall be construed to mean, as follows:

- a) <u>Trisikad/Pedicab</u> a bicycle with attached sidecar used to carry passenger that is not motorized.
- b) <u>Driver</u> the person authorized by the operator to drive the trisikad.
- c) <u>Operator</u> owner of the unit (Trisikad).
- d) <u>Public Utility</u> a trisikad used to carry passenger of cargo for a fee.

SECTION 3. It shall be unlawful for any person or persons to engage in transporting cargo with the use of trisikads for a fee within the 29 Barangay Districts of Ormoc City.

In consonance with the immediately preceding paragraph, it shall also be unlawful for any person or persons to engage in transporting passenger(s) with the use of Trisikads for any reason within the 29 Barangay Districts of Ormoc City.

The Ormoc City Traffic Division (PNP) is hereby directed to apprehend drivers/operators of Trisikads/Pedicabs operating within the 29 Barangay Districts of Ormoc City as provided for in the preceding paragraph.

SECTION 4. Any person or persons violating any provisions of this Ordinance shall upon conviction, suffer the penalty of FINE of not more than F1,000.00 or IMPRISONMENT of not more than 30 days, or both such fine and imprisonment, at the discretion of the court.

SECTION 5. All Ordinances or parts thereof which are inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 6. If for any reason, any provision of this Ordinance is declared unlawful or unconstitutional, the other provisions hereof not affected thereby shall remain valid and enforceable.

SECTION 7. This Ordinance shall take effect after its posting at the Bulletin Boards at the City Hall, Sangguniang Panlungsod, Executive Building and at the Public Market in the City of Ormoc for at least three (3) consecutive weeks, and its publication once in a local newspaper of general circulation whichever is later.

ENACTED, July 8, 1999.

RESOLVED, FURTHER, to furnish copies of this Ordinance, one each, to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the City Treasurer, the City Prosecutors' Office, the MTC Court, the City Police Director and the Precinct Commander, or PNP Headquarters; at least three (3) copies be posted on Bulletin Boards at strategic places, and others concerned in Ormoc City;
