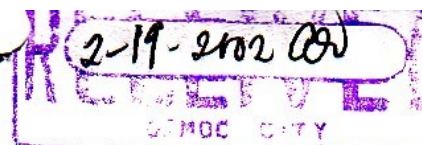

EXPLANATORY NOTE

Amendments to Ordinance No. 34 dated November 24, 1992 as amended by Ordinance No. 58 dated January 16, 1997 is but timely and reasonable.

At present, there is an increase in the number of tricycles for hire in the city. Some are changing their units, dropping the same and others are offering their units for sale.

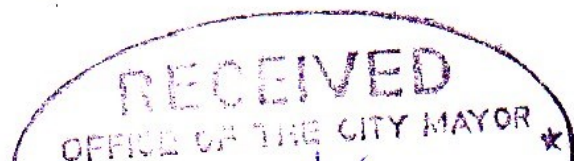
The Honorable Chairman, Committee on Transportation & Communications believes that in view of the increase in number of tricycles for hire as well as the mode of changing, dropping and sale of said units, it is imperative that amendments be made to conform with the standard requirements of Land Transportation Office (LTO) for registration of tricycle for hire.

Foregoing premises considered, on motion of City Councilor Jovencio A. Laurente, Chairman, Committee on Transportation & Communications, jointly seconded by City Councilors Gregorio A. Yrastorza, Jr. and Fe S. Lladoc; be it

RESOLVED, to adopt:

ORDINANCE NO. 089

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 34 DATED NOVEMBER 24, 1992 AS AMENDED BY ORDINANCE NO. 58 S. 1997 TO CONFORM WITH THE STANDARD REQUIREMENTS OF LTO FOR REGISTRATION OF TRICYCLES-FOR-HIRE AND UPDATING THE SAME TO BE MORE ADAPTABLE TO THE PRESENT SITUATION.



BE IT ORDAINED, by the 9th Sangguniang Panlungsod ng Ormoc in Session assembled, that:

SECTION 1. Section 3(a) of Article 1 of Ordinance 34 is hereby amended and incorporated thereto additional paragraph to read as follows:

"Tricycle-for-hire is a motor vehicle composed of a motorcycle fitted with a single-wheel side car or a motorcycle with a two-wheeled cab operated to render services to the general public for a fee. It shall have a maximum number of passengers of 6 sitting capacity;"

The motorcycle should at least be of 100 CC Power and not beyond ten (10) year old model.

"Operator shall employ only drivers duly licensed by Land Transportation Office for tricycle for hire. Certificates of Seminar on Defensive and Safety Driving is included as a requirement for granting franchise."

The Official fare for Zone I (Valencia-Kadaohan-Matica-a Route) shall be P5.00 and Zone II (Valencia-San Jose -P5.00; Valencia-Sabang Bao - P10.00; Labrador-Lilo-an Route - P7.00)

SECTION 2. Article V Sec. 2 is hereby modified by incorporating thereto the following paragraphs as follows:

4. Documents to be submitted to the Franchising Office for renewal of MTOP or all other application except for a new application shall only be two (2) copies instead of three (3).

5. Tricycle operators must secure clearance from the Franchising Office before they bring their units outside their line of operations for personal or emergency cases only. Said clearance shall be valid up to three (3) days only from date of approved application.

6. Insurance Company insuring our Motorized Tricycle for Hire shall be accredited by City Franchising Office and must have a Branch Office here in Ormoc City and not an agency.

7. Approval of the applications of MTOP shall be made on the renewal date of the Motor vehicle registration with LTO.


SECTION 11. This Ordinance shall take effect after publication in a newspaper of local circulation.
