PREFATORY STATEMENT

Section 13 Par. (b) of Republic Act 7160, otherwise known as the
Local Government Code of 1991, in part provides:

"(b) The Sanggunian of highly urbanized cities and component cities
whose charters prohibit their voters from voting for
provincial elective officials, hereinafter referred to in this
Code as Independent Component Cities, may in consultation with
the Philippine Historical Commission, change the name of the
following within its territorial jurisdiction:

X X X

- (3) Public elementary, secondary and vocational on technical
schools, community, colleges and non-chartered colleges"
(Emphasis supplied).

The Parents - Teachers Association and the Barangay Council of
Sabang Bao, this city, passed joint Resolution No. 02 s. 1997 entitled:
"A RESOLUTION RENAMING SABANG BAO NATIONAL HIGH SCHOOL TO RUSTICO
CAPAHI, SR. NATIONAL HIGH SCHOOL", citing among others the reason for
the same;

It is the consensus of this august Body that the will and desire of
the people of said locality be respected hence, this Sanggunian
interposes no objection to the renaming of the said school.

The National Historical Institute through a letter dated May 27,
1998 has this to say:

"Please be informed that the Institute interposes no objection to the said move based on the thorough deliberations of the Local School Board. However, it is recommended that the old name, which has been sanctified by usage by the residents of the Community, be placed underneath the new name in the signage as follows:

RUSTICO C. CAPAHI NATIONAL HIGH SCHOOL
(Sabang Bao National High School)

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Demosthenes F. Tugonon, duly seconded by City Councilor Nepomuceno P. Aparis I; be it

RESOLVED, to adopt:

ORDINANCE NO. 102

AN ORDINANCE RENAMING SABANG BAO NATIONAL HIGH SCHOOL TO RUSTICO C. CAPAHI, NATIONAL HIGH SCHOOL.

BE IT ORDAINED, by the 9th Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The Sabang Bao National High School, located at Brgy. Sabang Bao, Ormoc City is now presently called as RUSTICO CAPAHI NATIONAL HIGH SCHOOL.

SECTION 2. EFFECTIVITY. This Ordinance shall take effect after ten (10) days from its approval and after having published the same in full for a period of three (3) days in two (2) conspicuous and accessible places, pursuant to the provisions of Section 188 of R.A. 7160.

ENACTED, March 27, 2003.

RESOLVED, FURTHER, to furnish copies of this Ordinance, one each to His Honor, the City Mayor Carmelo J. Locsin; the Schools Division Superintendent, DepEd, Ormoc City, the Barangay Chairman, Sabang Bao, and others concerned, -all in Ormoc City;
