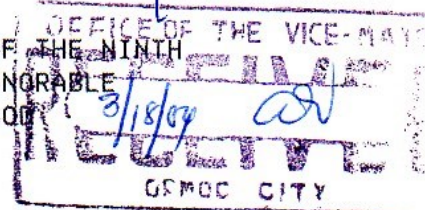

EXPLANATORY NOTE

This Sanggunian is in receipt of a letter dated 15 December 2004 from the Ormoc City Motorcab Operators and Drivers Association, Inc. re: Petition To Increase Motorcab/Tricycle Minimum Fare in view of the continued increase in the prices of gasoline and other petroleum products.

The present fare for tricycles was approved sometime September 11, 2003 wherein petitioner at that time requested for a FIFTY CENTAVOS (P0.50) fare increase and with the latest development in the oil industry wherein prices of which keep on increasing, it is also expected that operators of motorcabs have also to increase the rentals on boundaries of their units to cope up with the rising prices of spare parts thereby reducing the income of motorcab drivers making it difficult for them to make both ends meet.

WHEREFORE, foregoing premises considered, on motion of City Councilor Jovencio A. Laurente, Chairman, Committee on Transportation and Communications, duly seconded by City Councilor Gregorio A. Yrastorza, Jr.; be it

RESOLVED, to adopt:

ORDINANCE NO. 109

AN ORDINANCE AMENDING TITLE XII OF THE CODE OF GENERAL ORDINANCES OF ORMOC CITY BY ADDING CHAPTER IV, ENTITLED: "AN ORDINANCE AMENDING ORDINANCE NO. 105 SERIES OF 2003 OF ORMOC CITY BY INCREASING THE MINIMUM FARE RATE FOR MOTORIZED TRICYCLE AND ESTABLISHING A NEW RATE FOR ORMOC CITY AND ITS BARANGAYS."

BE IT ORDAINED, by the NINTH SANGGUNIANG PANLUNGSOD ng ORMOC, That:

SECTION 1. Ordinance No. 105 dated 11 September 2003 of the Sangguniang Panlungsod ng Ormoc is hereby amended to read as follows:

FARES:

The fare shall be established at a level that will provide the operator a reasonable return or profit and still be affordable to the general public.

The new fare rate shall be the existing rate within the city and its barangays.

Until such time that the Sangguniang Panlungsod shall prescribe otherwise, the official rate shall be in accordance with the following:

The foregoing schedule of fare rates should be posted prominently at the tricycle terminal, if any, and in a conspicuous part of the tricycle where said schedule can be easily seen by the passenger thereof.

Failure to observe this requirement constitute a violation of this Ordinance thereby making the operator and/or the driver of the tricycle liable to the penalty provided herein.


SECTION 2. This Ordinance shall take effect immediately after its publication once in a local newspaper of general circulation within the City of Ormoc.


