EXPLANATORY NOTE

The Rules and Regulations Implementing the Local Government Code of 1991, particularly Rule VIII, Article 43 thereof has empowered the Local Government Units to temporarily close or open any road, alley, park or square within its jurisdiction through an ordinance.

Article 45 of the said Implementing Rules and Regulations enumerates the instances whereby a Local Government Unit may close any national or local road, park or square, the duration of which shall be determined by the Local Chief Executive concerned in a written order, letter (b) of said article provides:

Art. 45. Temporary Closure -

(b) An LGU may temporarily close and regulate the use of any local street, road, thoroughfare, or public place where shopping malls, Sunday markets, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuff, commodities, or articles of commerce may be sold and dispensed to the general public."

Anent thereto, the Honorable City Mayor through 1st Indorsement dated November 26, 2007 has forwarded to this august Body the letterrequest of Rev. Msgr. Bernardo Pantin, Parish Priest, Sts. Peter and Paul Parish, for permission to utilize the sidewalk of the Parish Children's Playground as display area by some retailers in connection with the holiday season starting November 23, 2007 until January 15, 2008; Ord. No. 139

In consideration of said request and in order to ensure the protection and safety of the buying public, this Sanggunian believes that there is a need to close temporarily the sidewalks around the Parish Children's Playground fronting the Sts. Peter and Paul Church, specifically adjacent to the said plaza along Arradaza, I. Cataag, J. Navarro and C. Aviles Sts..

The said temporary closure shall be strictly imposed only in the above mentioned areas during the period specified.

FOREGOING PREMISES CONSIDERED, on motion of City Councilor, Ruben R. Capahi, Vice-Chairman, Committee on Public Safety, severally seconded by City Councilors Sotero M. Pepito, Fe S. Lladoc and Mariano Y. Corro; be it

RESOLVED, to enact:

ORDINANCE NO. 139

AN ORDINANCE TEMPORARILY CLOSING THE SIDEWALKS AROUND THE PARISH CHILDREN'S PLAYGROUND FRONTING THE STS. PETER AND PAUL CHURCH, SPECIFICALLY ADJACENT TO THE SAID PLAZA ALONG ARRADAZA, I. CATANG, J. NAVARRO AND C. AVILES STS. FROM MOVEMBER 23, 2007 TO JANUARY 15, 2008.

BE IT ORDAINED, by the Eleventh Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The above-enumerated areas around the Parish Children's Playground fronting the Sts. Peter and Paul Church, shall be temporarily closed effective November 23, 2007 until January 15, 2008 and shall be utilized as display area for authorized retailers of goods and merchandise which shall be sold to the general public during the holiday season.

SECTION 2. <u>Prohibition</u>. The said temporary closure shall be strictly imposed in the aforementioned areas and no person/retailer will be allowed to build any structure for vending purposes outside the area specified by Section 1 hereof. Any violation of this Section shall be a ground for automatic revocation of the vendor's permit to sell within the closed area.

SECTION 3. Effectivity. This ordinance shall take effect immediately upon approval.

ENACTED, December 07, 2007.

RESOLVED, FINALLY to furnish copies of this ordinance, one each to His Honor, the City Mayor Eric C. Codilla, the City Administrator, the City Legal Officer, the City Engineer, the City Planning & Development Coordinator, the Ormoc City Police Director, the Ormoc City Traffic Management Office and sufficient copies thereof be posted on the Bulletin Boards at conspicuous places, -all in Ormoc City.
