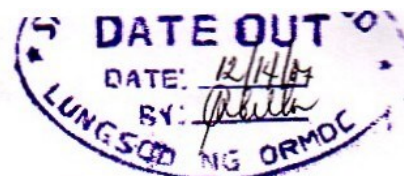

EXPLANATORY NOTE

On June 27, 2007, this Sanggunian enacted Ordinance No. 128, entitled: "AN ORDINANCE GRANTING FRANCHISE TO MR. RODOLFO B. PFLEIDER II, PROPRIETOR/MANAGER OF DUPTOURS SHUTTLE SERVICES, TO ESTABLISH, OPERATE AND MANAGE A PRIVATE MINI-TERMINAL AT BONIFACIO STREET, THIS CITY, EXCLUSIVELY FOR DUPTOURS SHUTTLE SERVICES";

That Section 3 of the aforementioned Ordinance only requires the GRANTEE to pay to the City Government of Ormoc, the franchise tax as provided for in the local tax ordinance, and such other taxes, fees and charges that may be imposed by the City, which turns out to be minimal vis-a-vis its capital investment and/or volume of business;

That on November 26, 2007, the Proprietor of Duptours Shuttle Services, Mr. Rodolfo B. Pfleider II, sent a letter to the City Mayor, Hon. Eric C. Codilla, offering "to give the City Government Twenty Five Pesos (P25.00) in every trip Ormoc to Tacloban from our Duptours Mini-Terminal over and above the Franchise Fee". A copy of aforementioned letter is hereto attached, and marked as ANNEX "A" hereof which letter was indorsed to this Sanggunian for favorable action;

That the City Government of Ormoc accepts the offer of Mr. Rodolfo B. Pfleider II, and hereby extends its gratitude and thanks;

FOREGOING PREMISES CONSIDERED, on joint motion of City Councilor Mariano Y. Corro and Claudio P. Larrazabal, Chairmen of the Committee on Ways & Means and Committee on Transportation and Communication, severally seconded by City Councilors Rafael C. Omega, Jr., Demosthenes F. Tugonon and Sotero M. Peptio; be it

RESOLVED, to enact:

ORDINANCE NO. 140

AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 128, ENTITLED: "AN ORDINANCE GRANTING FRANCHISE TO MR. RODOLFO B. PFLEIDER II, PROPRIETOR/MANAGER OF DUPTOURS SHUTTLE SERVICES, TO ESTABLISH, OPERATE AND MANAGE A MINI-TERMINAL AT BONIFACIO STREET, THIS CITY.

BE IT ORDAINED by the Eleventh Sangguniang Panlungsod ng Ormoc, in session assembled; that:

SECTION 1. Section 3 of Ordinance No. 128, is hereby amended by adding a paragraph thereto, to read:

"In addition to the above obligation, the GRANTEE shall pay Twenty-Five (P25.00) Pesos, per trip for any of its shuttle bus/van which departs from its Mini-Terminal in Ormoc City, which shall be paid every calendar quarter within the first twenty (20) days following the end of the applicable quarter. Payments made after the due date, a surcharge of twenty-five percent (25%) of the amount due, and an interest at the rate of two percent (2%) per month of the unpaid amount including the surcharge, shall be imposed, until such amount is fully paid, but in no case shall the total interest on the unpaid amount or portion thereof exceeds thirty-six (36) months. At the time of payment, the GRANTEE shall submit a sworn statement as to the number of trips made during the applicable quarter."


Section 2. This amendatory ordinance shall take effect on January 1, 2008.


