PREFATORY STATEMENT

The continuous increase of gasoline and other petroleum products causes drastic increases of the prices of all prime commodities including that of spareparts and other components necessary for the maintenance and operation of public and private vehicles. Following this situation, the owners and operators of Motorized Tricycles in this city were forced to pose an increase to the usual daily boundary rates of the drivers. This predicament greatly affects the daily income of motorcycle drivers making it more difficult for their families to make both ends meet.

Anent this situation, the Eleventh Sangguniang Panlungsod ng Ormoc is in receipt of an indorsement dated May 6, 2008 from the Office of the City Mayor regarding the Petition coming from the Ormoc Motorized Tricycle for Hire Operators and Drivers Association (OMTODA) for a One Peso (P1.00) increase of the minimum fare within the City Proper and all outline barangays in the City of Ormoc. The proposed fare increase is a way of alleviating the plight of the drivers and their families;

It can be recalled that the last fare increase being granted to Motorcabs/Tricycles was made on September of 2006 as embodied in Ordinance No. 130 dated September 7, 2006. Considering the successive oil price increases, the fare rates under said Ordinance is deemed no longer reasonable hence, there is a need to revise and amend the prevailing fare rates of Motorcycles/Tricycles befitting to the present economic situation.

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Communications & Transportation, jointly seconded by City Councilors Sotero M. Pepito and Mariano Y. Corro; be it

RESOLVED, to adopt:

ORDINANCE NO. 147

AN ORDINANCE FURTHER AMENDING ARTICLE III OF ORDINANCE NO. 34, AS AMENDED, ENTITLED: "AN ORDINANCE ESTABLISHING GUIDELINES, STANDARDS, RULES AND REGULATIONS FOR THE OPERATIONS OF MOTORIZED TRICYCLES-FOR-HIRE AND THE ISSUANCES OF MOTORIZED TRICYCLES OPERATORS PERMIT OR MTOP THEREBY IMPLEMENTING THE DEVOLUTION OF LTRFB'S FRANCHISING OVER TRICYCLES-FOR-HIRE TO THE CITY GOVERNMENT PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991 (R.A. NO 7160)" BY ESTABLISHING A NEW RATE FOR ORMOC CITY AND ITS BARANGAYS".

BE IT ORDAINED, by the Eleventh Sangguniang Panlungsod ng Ormoc in regular session assembled, that:

SECTION 1. Article III - FARES under Ordinance No. 34, as amended by the latest Amendatory Ordinance No. 130 dated September 7, 2006 of the Sangguniang Panlungsod ng Ormoc is hereby amended to read as follows:

FARES:

The fare shall be established at a level that will provide the operator and the driver a reasonable return or profit, and still be affordable to the general public.

Until such time that the Sangguniang Panlungsod shall prescribe otherwise, the official fare rates shall be in accordance with the following schedule, to wit:

The foregoing schedule of fare rates should be posted mandatorily in any part of the tricycle where said schedule can be easily seen by the passenger thereof. Failure to observe this requirement constitute a violation of this ordinance thereby making the operator and/or the driver of the tricycle liable to the penalty provided for in Article VII - Final Provisions, Section 2, Penal Provisions, Par. (b) of Ordinance No. 34. Furthermore, said schedule of fare rates shall be posted in three (3) conspicuous public places in the city and shall also be published once in a newspaper of general circulation in Ormoc City;

SECTION 2. All other provisions of Ordinance No. 34, as amended, which are not affected by this latest amendment remains to be in full force and in effect.

SECTION 3. All existing Ordinances, Executive Orders, Rules and Regulations inconsistent with this Ordinance are considered repealed or modified accordingly, as the case maybe.


SECTION 4. This Ordinance shall take effect immediately after it shall have been published once in a local newspaper of general circulation within the City of Ormoc and posted in public and conspicuous places for at least three (3) consecutive weeks.


