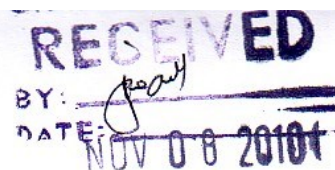

PREFATORY STATEMENT

Local Government Units are empowered, under the Rules and Regulations Implementing the Local Government Code of 1991, particularly rule VIII, Article 43 thereof, to temporarily or permanently close or open any road, alley, park or square within its jurisdiction through an ordinance.

Article 45 of the said Implementing Rules and Regulations enumerates the instances whereby a Local Government Unit may close any national or local roads, alley, park or square, the duration of which shall be determined by the Local Chief Executive concerned in a written order, letter (b) of said article provides;

"Art. 45. Temporary Closure-

- (b) An LGU may temporarily close and regulate the use of any local street, road, thoroughfare, or public place where shopping malls, Sunday markets, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuff, commodities, or articles of commerce may be sold and dispensed to the general public".

Anent thereto, the Office of the City Mayor through an urgent Indorsement dated October 27, 2010 has indorsed to the Twelfth Sangguniang Panlungsod ng Ormoc the request of Engr. Joseph Frederick A. Pepito, President, Ormoc Builders Association (ORBA) to allow them to utilize the road at the back of the City Hall Bldg., Macaasin St. and a portion of the Plaza Quadrangle for the Trade Exhibit, starting October 30, 2010 to March, 2011;

Furthermore, the purpose of the said request of the Ormoc Builders Association (ORBA) is to raise enough funds wherein the proceeds derive from its rental will be used to support for the various activities they are going to conduct which aimed to discover the artistic side of the Ormocanons;

The said temporary road closure shall be strictly imposed only in the above mentioned road and utilize a portion of the Plaza Quadrangle during the period specified;

FOREGOING, PREMISES CONSIDERED, ON MOTION OF City Councilor Demosthenes F. Tugonon, Chairman, Committee on Public Properties and Laws & Ordinances, duly seconded City Councilor Rafael C. Omega, Jr.; be it

RESOLVED, to enact,

ORDINANCE NO. 164

AN ORDINANCE TEMPORARILY CLOSING THE ROAD AT THE BACK OF THE CITY HALL, MACAASIN ST., AND UTILIZE A PORTION OF THE PLAZA QUADRANGLE EFFECTIVE OCTOBER 30, 2010 TO MARCH 2011.

BE IT ORDAINED, by the twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The road at the back of the City Hall Bldg., Macaasin St., shall be temporarily closed and a portion of the Plaza Quadrangle be utilized effective October 30, 2010 to March 2011.

SECTION 2. The road closure and the utilization of the portion of the Plaza Quadrangle shall be strictly implemented during the period above specified.

SECTION 3. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
