## PREFATORY STATEMENT

WHEREAS, the Local Government Code of 1991 specifically Section 21 thereof, empower the LGUs to temporarily close or open any road, alley, park or square within its territorial jurisdiction through an ordinance;

WHEREAS, Section 21, Par. (a) and (c) of the Code provides that:

Sec. 21 Closure and Opening of Roads –

- (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, x x x falling within its jurisdiction: x х х х х х.
- (c)Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, the duration of which shall be specified by the Х X X Local Chief Executive concerned through a written order: х X X X х х.

WHEREAS, in relation thereto the Office of the City Mayor, through an indorsement dated March 11, 2013 urgently request for the passage of an appropriate measure covering the request of United Nationalist Alliance (UNA)-Ormoc City Chapter, represented by Mr. Marcos Alfredo P. Larrazabal, to utilize the street in front of Old Gaisano Store as venue of the public rally of UNA Senatorial and Local candidates to be conducted on April 6, 2013 and May 10, 2013 respectively;

WHEREAS, in consideration of said request and in order to ensure the protection and safety of the people especially the buying public, this august Body believes that there is a need to temporarily close the street in front of old Gaisano Store known as Lopez Jaena St. beginning from the corner of Real and Lopez Jaena Sts. to the corner of Lopez Jaena and Rizal Sts.;

WHEREAS, the said temporary closure shall be strictly imposed only in the above mentioned area during the period specified;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Demosthenes F. Tugonon, Chairman, Committee on Public Properties, duly seconded by City Councilor Antonio M. Codilla, be it

**RESOLVED**, to enact:

## ORDINANCE NO. 182

AN ORDINANCE TEMPORARILY CLOSING A PORTION OF LOPEZ JAENA STREET (IN FRONT OF GAISANO CAPITAL) FROM THE CORNER OF REAL-LOPEZ JAENA STREETS TO THE CORNER OF RIZAL-LOPEZ JAENA STREETS ON APRIL 6, 2013 AND MAY 10, 2013, AT 6:00 P.M. TO 12:00 MIDNIGHT RESPECTIVELY.

BE IT ENACTED, by the Tweifth Sangguniang Panlungsod ng Ormoc, That:

SECTION I. The portion of Lopez Jaena Street (in front of Gaisano Capital/Old Gaisano Store) from the corner of Real-Lopez Jaena Sts. to the corner of Rizal-Lopez Jaena Sts. shall be temporarily closed on April 6, 2013 and May 10, 2013 respectively, to be utilized as venue of the public rally of UNA Senatorial and Local candidates to be conducted on said dates.

SECTION 2. The said temporary closure shall be strictly imposed on the said area on the dates specified. In effect thereof, all public and private vehicles will be prohibited to enter or pass on the affected premises.

SECTION 3. This Ordinance shall take effect immediately subject to the compliance of the necessary posting and publication requirements as provided for in the Local Government Code of 1991.
