RESOLVED, to pass and enact:

ORDINANCE NO. 024

AN ORDINANCE AMENDING SECTION 6, NO. 1 OF  
ORDINANCE NO. 22 OTHERWISE KNOWN AS "AN  
ORDINANCE IMPLEMENTING THE MATERNAL CARE  
INCENTIVE PROGRAM".

BE IT ORDAINED by the 13<sup>th</sup> Sangguniang Panlungsod ng Ormoc in Regular Session assembled, That:

SECTION 1. Section 6, No. 1 of Ordinance No. 22 is hereby amended to read as follows:

**SECTION 6. SOURCE OF FUND.**

- 1. The MCIP financial incentive scheme shall be fully funded from the "Maternity Care Package Receipts of PhilHealth" as part of the Operational Cost.**

SECTION 2. Any Ordinance or provision thereof in conflict with this Ordinance is hereby repealed accordingly.


SECTION 3. This Ordinance shall take effect immediately upon its approval and compliance of the posting and publication requirements.
