

PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod ng Ormoc (this Sanggunian) was in receipt of a communication from the Department of Budget and Management (DBM) Regional Office VIII dated June 15, 2017 stating that:

"Pursuant to the provisions of the Local Government Code of 1991 (RA No. 7160), our review of the FY 2017 Supplemental Budget No. 1 of the City of Ormoc, involving a total appropriation of P72, 657,131.48 under Appropriation Ordinance No. 2017-002 to 2017-009 submitted to this Office for review on April 29, 2017, reveals substantial compliance with the same law and its implementing rules and regulations except that the newly created position of Population Program Officer II is not properly allocated to its proper position title and salary grade (SG) pursuant to DBM LBC No. 61, dated March 18, 1996. The position should be allocated a SG of 15 but the compensation appropriated is for a SG 11 only."

WHEREAS, the same communication above cited made a ruling stating that:

"Accordingly, the said appropriation ordinance is declared inoperative in part as of the date of effectivity, subject to the posting requirement under Section 59 of RA 7160, and further subject to the following condition that the newly created position of Population Program Officer II should be allocated its appropriate level of position and salary grade assignment."

WHEREAS, to recall, Ormoc City Ordinance No. 011 s 2016 otherwise known as Ormoc City Population and Sustainable Development Ordinance of 2016 was enacted by this Sanggunian on October 19, 2016 for the purpose of furthering sustainable and inclusive development in the city and to implement a comprehensive policy on population and development that is anchored on empowering families helping couples and individuals decide on the number and spacing of their children to ensure better quality of life of their respective families, promoting responsible parenthood as a way of life, establishing adolescent health and youth empowerment program, and effective urban management strategies putting people at the center in all sustainable development initiatives for the city ensuring that nobody shall be left behind;

WHEREAS, the amendment sought is for the purpose of responding to the observation of the DBM and to cure the defect or inaccuracy in the pertinent section of subject ordinance and as per DBM ruling make the appropriation ordinance operative;

WHEREAS, this foregoing premises considered, this Sanggunian finds merit in the request for correction and amendment of pertinent sections in Ordinance No. 011 series of 2016;

WHEREFORE, all foregoing premises considered, on motion of SP Member Nolito M. Quilang, Chairman of the Committee on Good Government, severally seconded by SP Members Rolando M. Villasencio, Tomas R. Serafica, Mario M. Rodriguez, Gregorio G. Yrastorza III, Vincent L. Rama, Benjamin S. Pongos, Jr., Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, to enact:

**ORDINANCE NO. 041**

**AN ORDINANCE AMENDING SECTION 11 AND SECTION 12 OF ORDINANCE NO. 011 series 2016, TITLED "AN ORDINANCE INSTITUTING A LOCAL POPULATION AND SUSTAINABLE DEVELOPMENT STRATEGY AND PRESCRIBING THE COMPOSITION OF ITS IMPLEMENTING STRUCTURE AND PROVIDING FUNDS THEREFOR".**

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

**SECTION 1.** This Section 11 of Ordinance No. 011 is hereby amended to read as follows:

*"SECTION 11. Nomenclatures of the New Positions Created. The newly created positions under the IPGDO and the corresponding Salary Grade Level are as follows:*

NUMBER OF ITEMS	POSITION	SALARY GRADE
1	Population Program Officer IV	22
2	Population Program Officer I	11
1	Administrative Assistant II	8"

**SECTION 2.** This Section 12 of Ordinance No. 011 is hereby amended to read as follows:

*"SECTION 12. Qualifications of the New Positions – The various positions in the CPGDO shall have the following qualifications:*

x x x x

*B. The Population Program Officer I (SG 11) shall have the following qualifications:*

- (1) Must be a Filipino citizen permanently residing in Ormoc City;*
- (2) Must be civil service eligible (Second level/professional);*
- (3) Must obtain a relevant bachelor's degree;*
- (4) At least one (1) year of relevant work experience; and*
- (5) Must have earned four (4) hours of relevant training.*



*C. The Administrative Assistant II (SG 8) shall have the following qualifications:*

- (1) Must be a Filipino citizen permanently residing in Ormoc City;*
- (2) Must be civil service eligible (First level/sub-professional);*
- (3) Must have at least two (2) years of college education;*
- (4) At least one (1) year of relevant work experience; and*
- (5) Must have earned four (4) hours of relevant training."*

**SECTION 3. REPEALING CLAUSE.** Any provision of ordinances, rule and regulations and/or parts thereof inconsistent with the provisions of this ordinance are hereby modified, amended, and/or repealed accordingly.

**SECTION 4. SEPARABILITY CLAUSE.** Should any provision of this Ordinance be declared unconstitutional or invalid by any court of competent jurisdiction, the provisions that are not affected thereby shall continue to be in full force and effect.

**SECTION 5. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval and after compliance with the requirements of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.
