

PREFATORY STATEMENT

WHEREAS, on January 4, 2018 this august Body enacted Appropriation Ordinance No. 2018-002, entitled: "AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF EIGHT HUNDRED SEVENTY-SEVEN THOUSAND SIX HUNDRED FIFTY-FIVE PESOS (P877,655.00) TO BE TAKEN FROM OUT OF THE REVERSION OF CY 2014 CONTINUING APPROPRIATION ACCOUNT - OTHER PROPERTY, PLANT AND EQUIPMENT OF THE CITY AGRICULTURE OFFICE TO SUPPLEMENT THE ACCOUNT - OFFICE EQUIPMENT OF SAME OFFICE FOR THE PURCHASE OF THREE(3) UNITS FLOOR MOUNTED AIR CONDITIONER (STANDING AIRCON)";

WHEREAS, the subject appropriation ordinance is deemed a supplemental budget to the approved General Fund Annual Budget of the city for FY 2017 which provides funding for the proposed purchase of Three (3) air conditioning units for the Multi-purpose Hall of the City Agriculture Office as requested by the OIC-City Agriculturist, Ms. Maria Elena Mendoza;

WHEREAS, the Budget Operations Manual for LGUs issued by the Department of Budget and Management (DBM) provides that Supplemental Budgets should be authorized within the Fiscal Year covered by the Annual Budget hence, an Appropriation Ordinance covering a Supplemental Budget for the year 2017 can no longer be passed after December 31, 2017;

WHEREAS, Section 353 of the Local Government Code of 1991 provides that the official Fiscal Year of the LGUs shall be the period beginning with the 1st day of January and ending with the 31st day of December of the same year;

WHEREAS, considering that A.O No. 2018-002 which is a General Fund Supplemental Budget for CY 2017 was enacted on January 4, 2018 which date is beyond the Budget Year 2017, its enactment was found to be not in conformity with existing budgetary rules, laws and regulations thus, it is imperative that the same be repealed accordingly;

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

ORDINANCE NO. 057

AN ORDINANCE REPEALING APPROPRIATION ORDINANCE NO. 2018-002 ENTITLED: "AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF EIGHT HUNDRED SEVENTY-SEVEN THOUSAND SIX HUNDRED FIFTY-FIVE PESOS (P877,655.00) TO BE TAKEN FROM OUT OF THE REVERSION OF CY 2014 CONTINUING APPROPRIATION ACCOUNT - OTHER PROPERTY, PLANT AND EQUIPMENT OF THE CITY AGRICULTURE OFFICE TO SUPPLEMENT THE ACCOUNT - OFFICE EQUIPMENT OF SAME OFFICE FOR THE PURCHASE OF THREE (3) UNITS FLOOR MOUNTED AIR CONDITIONER (STANDING AIRCON)".

Be it ordained by the 14th Sangguniang Panlungsod in Regular Session assembled, That:

SECTION 1. The General Fund Supplemental Budget of the City of Ormoc for FY 2017 denominated as Appropriation Ordinance No. 2018-002 is hereby repealed.

SECTION 2. - This Ordinance shall take effect immediately after the compliance of the necessary publication and posting requirements as provided in the Local Government Code of 1991.
