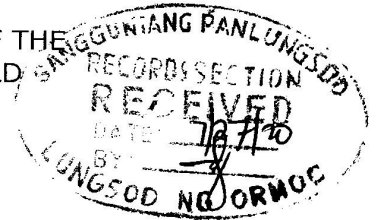

PREFATORY STATEMENT

WHEREAS, the Local Government Unit shall establish adequate, effective and enabling mechanism and support systems that will ensure the meaningful participation of the youth in local governance and nation building;

WHEREAS, Sec.30, Chapter VI of RA 10742 otherwise known as the SK Reform Act of 2015 provides that every local government unit shall conduct an annual activity to be known as "The Linggo ng Kabataan" on the week where the 12th of August falls to coincide with the International Youth Day.

WHEREAS, through the Linggo ng Kabataan, the youth is given a venue that gives due importance to the development of an active and empowered youth sector;

WHEREAS, Ordinance No. 015 series of 2016 declared as a policy of the City Government to promote and protect the physical, moral, spiritual, intellectual and social well-being of the Filipino youth, inculcating in them patriotism and nationalism, and encourage their involvement in public and civic affairs and hereby established the Ormoc City Youth Development Program to implement programs that will respond to the concerns of the in-school youth, out of school youth, working youth, and youth with special needs as well as advance the welfare of the young people and empower them to effectively make life choices and decisions;

WHEREAS, the City Government of Ormoc celebrates the annual Linggo Ng Kabataan pursuant to Section 30 of Republic Act 10742 otherwise known as "SK Reform Act of 2015" and DILG Memorandum Circular No. 2019-122 which encourages all Local Chief Executives to "initiate youth activities in observance of Linggo ng Kabataan and International Youth Day";

WHEREAS, other Local Government Units in the country have respectively passed their own resolutions and/or ordinances pertaining to the said event in order to "localize" the celebration of Linggo Ng Kabataan pursuant to Section 30 (b) of SK Reform Act of 2015;

WHEREFORE, on motion of SP Member Joan Marbie C. Simbajon, Chairman of the Committee on Youth and Sports Development, severally seconded by SP Members Tomas R. Serafica, Esteban V. Laurente, Gregorio G. Yrastorza III, Peter M. Rodriguez, Roiland H. Villasencio, Lalaine A. Marcos, Nolito M. Quilang, Jasper M. Lucero and Vincent L. Rama; be it

RESOLVED, to enact:

**ORDINANCE NO. 034
(Series of 2020)**

**AN ORDINANCE INSTITUTIONALIZING ORMOCANON
LINGGO NG KABATAAN TO BE HELD STARTING
SUNDAY ON OR BEFORE AUGUST 12 OF EVERY
YEAR.**

BE IT ENACTED by the 15th Sangguniang Panlungsod in Regular Session assembled that:

SECTION 1. TITLE. The title of this ordinance shall be "The Ormocanon Linggo ng Kabataan Ordinance or LNK Ordinance".

SECTION 2. LINGGO NG KABATAAN (LNK) CELEBRATION. Pursuant to Section 30, Chapter VI of RA 10742 otherwise known as the SK Reform Act of 2015, the City of Ormoc hereby celebrates the "Linggo ng Kabataan" to be held starting Sunday on or before August 12 of every year.

SECTION 3. General Objectives. The LNK Ordinance aims to achieve the following:

1. To inculcate among youth the love of country, discipline, civic-mindedness, unity, courage, respect for the rights of others, sportsmanship and quest for excellence.
2. To promote unity, camaraderie and cooperation among different sub-sectors of the youth.
3. To serve as a training ground for SKs and Youth Leaders in the formulation, management, and implementation of nation-building policies and programs.
4. To promote the Sangguniang Kabataan as an organization and initiator of programs vital for the enhancement of the social, cultural, intellectual, moral, spiritual and physical development of the youth, in close partnership with youth organizations and other concerned stakeholders.

SECTION 4. LINGGO NG KABATAAN (LNK) EXECUTIVE COMMITTEE. The City Youth Development Council shall recommend to the City Mayor for approval the creation and composition of the LNK Executive Committee not later than February of each year. The said committee shall come up with a consolidated plan of programs, projects and activities for the celebration and take the lead in the implementation thereof. The Executive Committee may organize working committees composed of registered youth organizations and Sangguniang Kabataan Chairpersons to ensure success in the implementation of the plan.

SECTION 5. LNK PROGRAMS AND ACTIVITIES. The Sangguniang Kabataan Federation and the City Youth Development Office as well as all Sangguniang Kabataan Councils at the Barangay Level shall come up with their respective plans for the LNK which shall then be consolidated by the LNK Executive Committee. A plan may include but not limited to the following:

1. Capacity-Building
 - Leadership Training/Youth Camp Program
 - Employability Skills Training
 - Value Formation, Citizenship/Nation-Building Seminar
2. Health Services and Adolescent Reproductive Health Program
3. Out of School Youth Programs
4. Socio-Cultural and Sports Development
5. Disaster Preparedness and Climate Change Adaptation
6. Drug Prevention
7. Other related programs focusing on youth development and empowerment especially those that promote sense of responsibility and build capacities for nation-building.

SECTION 6. LINGGO NG KABATAANG BARANGAY. Aside from the city-wide Linggo ng Kabataan celebration, all barangays of Ormoc City shall adopt this ordinance and conduct week-long activities with the same goals stated in Section 3 of this ordinance.

A barangay Executive Committee shall also be formed to formulate and implement programs pursuant to Section 5 of this ordinance, which shall be composed of the following:

CHAIRPERSON : Punong Barangay
CO-CHAIRPERSON : Sangguniang Kabataan Chairperson
SECRETARIAT : Sangguniang Kabataan Secretary
MEMBERS : SK Members
: Representatives, youth organizations in the barangay
: Representatives, Student Body Organizations in
barangay
: Representatives, Katipunan ng Kabataan

The Barangay Executive Committee on Linggo ng Kabataan shall submit documentation of their Linggo ng Kabataan celebration to the SK Federation Office not later than three (3) weeks after its implementation.

SECTION 7. ORMOCANON LITTLE OFFICIALS. As part of the opening activity of the Ormocanon Linggo Ng Kabataan, there shall be an election of youth counterparts of all the elective officials (Mayor, Vice-Mayor, 10 Councilors and 2 Ex-Officio) including heads of Local Government units and all barangay officials to be appointed from among in-school and community Ormocanon youth ages thirteen (13) to seventeen (17).

Elections shall be done within three (3) weeks prior to the Linggo ng Kabataan. All elective and appointive little officials shall take their oath duly administered by the City Mayor. They shall hold office as boy and girl officials for the entire duration of the Linggo ng Kabataan and perform functions and duties as may be provided in this Ordinance. The said elective and appointive little officials shall be subject to a one (1) day Orientation Program to be conducted by the City Youth and Development Office.

SECTION 8. FUNDS. The required funds needed for the implementation of the Ormocanon Linggo ng Kabataan shall be duly allocated as integrated in the budget of SK, City Youth Development Office, City Mayor's Office, and other concerned agencies and entities, subject to the usual accounting and auditing procedures in the disbursement of funds. Other funds allocated for the said event by respective SK Councils pursuant to their Annual Barangay Youth Investment Plan (ABYIP), Comprehensive Barangay Youth Development Plan (CBYDP) and their respective Annual Budget shall be taken into consideration by the Executive Committee as one of the source of funds for the said event.

SECTION 9. APPLICABILITY CLAUSE. The provisions of existing ordinances dealing on the same subject matter which are not in conflict with, or contrary to the provisions of this Ordinances are hereby adopted and made an integral part of this Ordinance.

SECTION 10. REPEALING CLAUSE. All ordinances, rules and regulations, or parts thereof, the provision of which are in conflict with or contrary to the provision of this Ordinance are hereby repealed, amended and modified accordingly.


SECTION 11. EFFECTIVITY CLAUSE. The provision of this ordinance shall take effect immediately.


