EXPLANATORY STATEMENT

WHEREAS, in the letter of the Waterworks Superintendent II addressed to the City Mayor's Office dated March 13, 2020, the former pointed out that there is a need of a Technical Staff to conduct inspection and work as a Project Inspector for the several construction projects that had been and will be undertaken by the Ormoc Waterworks System Administration (ORWASA);

WHEREAS, the ORWASA office have two existing (2) vacant items, Crafts and Trade Helper with Salary Grade 1, not necessary for regular employment and can be replaced by a 300 Order to do such task;

WHEREAS, the Waterworks Superintendent requested to scrap the abovementioned vacant items which have a higher budget appropriation needed for the creation of one (1) additional position of Engineer I, and necessary in the technical operation of several ORWASA operations;

WHEREAS, the Sangguniang Panlungsod as the legislative Body of the City, has the responsibility to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city (Sec. 458, LGC of 1991). Furthermore, the Code provides that the Sangguniang Panlungsod shall approve ordinances to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees and provide for expenditures necessary for the proper conduct of programs, services, and activities of the city government (Sec. 458 (1)(viii) of LGC of 1991);

NOW, THEREFORE, on motion of SP Member Jasper M. Lucero, Chairman on Committee of Good Government & Oversight and Committee on Economic Enterprise, severally seconded by SP Members Roiland H. Villasencio, Nolito M. Quilang, Esteban V. Laurente, Tomas R. Serafica, Gregorio G. Yrastorza III, Lalaine M. Marcos and Joan Marbie C. Simbajo; be it

ORDINANCE NO. 045 (Series of 2020)

AN ORDINANCE CREATING ONE (1) ADDITIONAL POSITION OF ENGINEER I FOR THE ORMOC WATERWORKS SYSTEM ADMINISTRATION (ORWASA) AND APPROPRIATING NECESSARY FUNDS THEREOF.

BE IT ORDAINED by the 15th Sangguniang Panlungsod of Ormoc City, that:

SECTION 1. CREATION OF NEW POSITION- There is hereby created one (1) new position under the Construction and Maintenance Section of Ormoc Waterworks System Administration (ORWASA) and the corresponding Salary Grade as follows:

SECTION 2. ABOLITION OF EXISTING POSITIONS- The following vacant/unfilled positions under the Construction and Maintenance Section of ORWASA shall be abolished to give way to the creation of one (1) Engineer I with SG 12.

SECTION 3. QUALIFICATIONS OF THE ENGINEER I- The Engineer I (SG 12) position shall have the following qualifications:

SECTION 4. DUTIES AND FUNCTIONS OF THE ENGINEER I – The Engineer I shall have the following duties and functions:

- 1. Prepare program of works of ORWASA construction project on Level II and Level III water supply.
- Inspection and monitor ORWASA construction project on Level II and Level III.
- 3. Supervise civil works in the maintenance operation.
- 4. Perform as project inspector in all ORWASA construction project on Level II and Level III.
- 5. Performs such other functions as the ORWASA head may direct.

SECTION 5. SCREENING AND APPOINTMENT PROCEDURES- Screening of prospective applicants including hiring procedures shall be in accordance under Civil Service Law, rules and regulations. The appointments of the respective positions created under Section 1 shall be issued by the City Mayor in accordance with Civil Service Law, rules and regulations, in relation to the provisions of RA 7160, the Local Government Code of 1991. Qualified, screened and recommended applicants shall be entitled with respective compensations and benefits upon assumption to office and after their appointments shall have been attested to by the Civil Service Commission.

SECTION 6. APPROPRIATIONS- The amount needed to carry out the provisions of this Ordinance for Calendar Year 2020 shall be sourced from the abolished positions abovementioned. For succeeding years, the appropriation for the newly created positions shall be included in the annual budget of the ORWASA.

SECTION 7. REPEALING CLAUSE – Any provision of ordinances, rules and regulations and/or parts thereof inconsistent with the provisions of this ordinance are hereby modified, amended, and/or repealed accordingly.

SECTION 8. SEPARABILITY CLAUSE – Should any provision of this Ordinance be declared unconstitutional or invalid by any court of competent jurisdiction, the provisions that are not affected thereby shall continue to be in full force and effect.

SECTION 9. EFFECTIVITY- This Ordinance shall take effect immediately upon approval and after compliance with the requirements of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.
