RESOLUTION NO. 93

"WHEREAS, this august body is in receipt of the review letter of the Acting Minister of Finance, Honorable Alfredo Pio de Roda, Jr. dated September 17, 1986, apropos to Tax Ordinance No. 3, series of 1986, among others, that Section 2 thereof re: effectivity should be reworded to conform to the requirement as mandated by the Local Tax Regulations No. 1-86, dated May 21, 1986 of said Ministry;

NOW, THEREFORE, on motion of Kagawad Suan, seconded by Kagawad Subingsubing; be it

"RESOLVED, to adopt:

TAX ORDINANCE NO. 4

AN ORDINANCE TO AMEND SECTION 2-EFFECTIVITY OF TAX ORDINANCE NO. 3, OTHERWISE KNOWN AS "AN ORDINANCE TO AMEND SECTION 2.2.1.1., ARTICLE 1, CHAPTER 2, TITLE II, OF TAX ORDINANCE NO. 1, OTHERWISE KNOWN AS THE 'ORMOC CITY REVENUE CODE OF 1977', AS AMENDED, LEVYING THE OCCUPATION TAX ON PROFESSIONS OR CALLINGS, PURSUANT TO LOCAL TAX REGULATIONS NO.1-86, DATED MAY 21, 1986 OF THE MINISTRY OF FINANCE."

BE IT ORDAINED, By the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment.-Section 2-Effectivity of Tax Ordinance No. 3, is hereby amended to read as follows:

"SECTION 2. Effectivity. - This Tax Ordinance shall take effect two (2) months after its publication in a newspaper of general circulation.
