AN ORDINANDE TO AMEND SECTION 2-EFFECTIVITY OF TAX ORDINANCE ND. 3, OTHER LISE KNOWN AS "AN ORDINANCE TO AMEND SECTION 2.2.1.1., ARTICLE 1, CLAPTER 2, TITLE II, OF TAX ORDINANCE NO. 1, OTHERWISE KNOWN AS THE 'ORMOC CITY REVENUE CODE OF 1977', AS AMENDED, LEVYING THE OCCUPATION TAX ON PROFESSIONS OR CALLINGS, PURSUANT TO LOCAL TAX REGULATIONS NO.1-86, DATED MAY 21, 1986 OF THE MINISTRY OF FINANCE."
