TAX ORDINANCE NO. 2002-001

AN ORDINANCE AMENDING ARTICLE 9 SECTION 86 PARAGRAPH (a) OF TAX ORDINANCE NO. 93-01 BY INCREASING THE FEE FOR THE SEALING AND LICENSING OF WEIGHTS AND MEASURES FROM TWENTY PESOS (P20.00) TO FIFTY PESOS (P50.00).

BE IT ORDAINED, by the NINTH SANGGUNIANG PANLUNGSOD ng $\ensuremath{\mathsf{ORMOC}}$ in Session, that:

SECTION 1. Art. 9 Sec. 86 par (a) of Tax Ordinance No. 93-01 is hereby amended to read as follows:

ARTICLE 9 - Fees for Sealing and Licensing of Weights and Measures

SECTION 86. <u>Imposition of Fees</u>. There is hereby imposed the following fees on sealing of weights and measures, on every persons, partnership, or corporation before using instrument of weights and measures within the City in accordance with the following schedules, to wit:

a) The City hereby levies a fee of fifty pesos (P50.00) for the sealing and licensing of weights and measures.

SECTION 2. <u>EFFECTIVITY</u>. This Ordinance shall take effect immediately after its publication once in a local newspaper of general circulation within the City of Ormoc.

ENACTED, April 25, 2002.
