

PREFATORY STATEMENT

WHEREAS, Article 274 of the Rules and Regulations Implementing the Local Government Code (LGC) of 1991, provides: "Local Government Units (LGU) may exercise the power to levy taxes, fees or charges on any base or subject not otherwise specifically enumerated in this Rule or taxed under the provisions of the National Internal Revenue Code (NIRC), as amended, or other applicable laws XXX";

WHEREAS, as mandated in Sections 132, Section 447 paragraph 2 (ii) and Section 316 of the Local Government Code, the Local Sanggunians are to enact revenue ordinances and to update its Local Revenue Codes. In updating the tax ordinances the LGUs are to revisit and amend their existing ordinances in accordance with LGC of 1991;

WHEREAS, as provided by Section 191 of LGC the tax rates of the LGU Revenue Code should be updated and rationalized once every five years, to ensure the sustainability and buoyancy of various local taxes, while rates for regulatory/service fees and charges should be updated to make these fees and charges commensurate to the cost of the regulation and the services provided;

WHEREAS, the City Health Department is continuously upgrading their services for the citizens of Ormoc City and of neighbouring towns with the construction of new facilities and laboratories. However, fees for its services remain the same for the past twenty (20) years;

WHEREAS, to keep up with the increasing cost of laboratory reagents and solutions and likewise maintenance of laboratory apparatus and equipment, there is a need to increase the rates of its services;

WHEREAS, in compliance of the legal requirement provided for in the LGC that in the enactment of any revenue-raising ordinance as herein, a prior public hearing must be conducted, one indeed took place on January 07, 2021;

WHEREAS, foregoing premises considered, this Sanggunian finds great merit in the City Mayor's requested amendment intended for the benefit of the City and to the community as a whole;

WHEREFORE, on motion of SP Member Tomas R. Serafica, Chairman, Committee on Ways and Means, severally seconded by SP Member Nolito M. Quilang, Roiland H. Villasencio, Vincent L. Rama, Lalaine A. Marcos, Joan Marbie C. Simbajon, Esteban V. Laurente and Gregorio G. Yrastorza, III; be it

RESOLVED, to enact:

**TAX ORDINANCE NO. 003
(Series of 2021)**

AN ORDINANCE REVISING TAX ORDINANCE NO. 2000-003 OTHERWISE KNOWN AS "AN ORDINANCE ADOPTING THE SCHEDULE OF FEES/CHARGES FOR THE USE OF FACILITIES AT THE ORMOC CITY HEALTH OFFICE", THEREBY FIXING THE FEES ON HEALTH SERVICES AND PROCEDURES RENDERED BY THE CITY HEALTH DEPARTMENT, AND FOR OTHER PURPOSES.

Be it ordained by the Sangguniang Panlungsod of Ormoc City, Leyte that:

SECTION 1. TITLE -This ordinance shall be known as the "**CITY HEALTH SERVICES FEES AND CHARGES ORDINANCE OF 2021**"

SECTION 2. IMPOSITION OF FEES ON HEALTH SERVICES AND PROCEDURES. - There shall be imposed applicable fees for select health services and procedures rendered by the City Health Department, fixed as follows:

A Permit to discharge Septic Tank shall be secured from the City Health Department and the location for the disposal shall be jointly approved by the Environment & Natural Resources Office and the City Health Department.

The foregoing fees, subject to Section 3 hereof, shall be paid, upon order of payment by the City Health Department or his/her duly authorized representative, to the City Treasurer or his/her duly authorized representative, for which an official receipt shall be issued.

In the absence of a competent professional to undertake the requisite testing, reading, and/or interpretation of the foregoing examinations, the Local Government Unit, through the Local Chief Executive, may enter into a contract of service with a duly licensed professional, in accordance with pertinent laws, rules, and regulations.

SECTION 3. The above fees will not be collected if the patient has been certified indigent by the City Social Welfare Department.

SECTION 4. REPEALING CLAUSE - TAX ORDINANCE NO 2000-003 is hereby expressly repealed. All Ordinances, rules, regulations, and/or Resolutions, or portions thereof, inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 5. SEPARABILITY CLAUSE - If for any reason any provision of this Ordinance is declared unconstitutional or invalid by any competent court, the other parts or provisions hereof which are not affected thereby shall continue in full force and effect.

SECTION 6. EFFECTIVITY - This Ordinance shall take effect immediately upon approval and after compliance with necessary posting and publication requirements of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.


