PREFATORY STATEMENT

PRESENTED to the Twelfth Sangguniang Panlungsod ng Ormoc for consideration is an urgent communication dated February 14, 2011 from the Office of the City Mayor the subject thereof is a request for a supplemental appropriation amounting to TWENTY ONE MILLION TWO HUNDRED SIXTY FIVE THOUSAND PESOS (P21,265,000.00) for the CY 2010 CNA Incentive of regular and casual employees of the City Government of Ormoc, including appointed and elected city officials. Each qualified employee will receive P20,000.00 subject to pro rata as to the number of months in the service.

For purposes of determining the number of employees who are qualified to receive the benefit, the Human Resource Management Office submitted a summary stating therein a total of 1,084 employees with the corresponding amount of their respective entitlement .

With respect to the funding requirement for the benefit, the City Budget Officer through her 4th Indorsement dated February 21, 2011, certified that funds are available to cover the requested appropriation for the CNA Incentive in the amount of TWENTY ONE MILLION TWO HUNDRED SIXTY FIVE THOUSAND PESOS (P21,265, 000.00) to be taken from out of the Unappropriated Surplus, End of Year 2010.

Furthermore, the City Treasurer also issued a Certification dated February 21, 2011 stating therein that funds are available under the Unappropriated Surplus, End of Year 2010, and the same may be used as a funding source for the aforementioned benefit, subject however, to accounting and auditing procedures;

FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Jose C. Alfaro, Jr., Vice-Chairman, Committee on Appropriation, duly seconded by City Councilor Antonio M. Codilla; be it

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2011-002
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY ONE MILLION TWO HUNDRED SIXTY FIVE THOUSAND PESOS (P21,265,000.00) FOR THE CNA INCENTIVE OF REGULAR AND CASUAL EMPLOYEES OF THE CITY GOVERNMENT OF ORMOC, INCLUDING APPOINTED AND ELECTED CITY OFFICIALS AT TWENTY THOUSAND PESOS (P20,000.00) EACH SUBJECT TO PRO RATA AS TO THE NUMBER OF MONTHS IN THE SERVICE - TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2010.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWENTY ONE MILLION TWO HUNDRED SIXTY FIVE THOUSAND PESOS (P21,265,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the CNA Incentive of city officials and employees of the City Government of Ormoc at P20,000.00 each, to be taken from the Unappropriated Surplus, End of Year 2010.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.



ENACTED, February 24, 2011.




