PREFATORY STATEMENT

PRESENTED to this Sanggunian for consideration is an indorsement dated February 28, 2011 from the Office of the City Mayor relative to the letter-request of Dr. Nelita D. Navales, City Health Officer II, for a supplemental appropriation in the amount of FIVE HUNDRED THOUSAND PESOS (P500,000.00) for the incentives of the District Health Personnel attending maternal deliveries after office hours. Supposedly, the appropriation for the said incentives is to be included in the Annual Budget of the City in consonance with the provisions of Ordinance No. 159, otherwise known as "The Ormoc City Maternity and Newborn Care Ordinance of 2010" particularly Section 10 thereof, and its Operational Guidelines and Implementing Rules and Regulations (IRR). However, due to inadvertence the matter was not included in the Annual Budget of the city for CY 2011, hence the request.

The City Budget Officer, through a Certification dated February 28, 2011 certified that funds are available for the requested appropriation to be taken from out of the Unappropriated Surplus, End of Year 2010.

Furthermore, the City Treasurer issued a Certificate of Availability of Funds dated February 28, 2011 stating therein that funds amounting to Five Hundred Thousand Pesos (P500,000.00) are available from the Unappropriated Surplus, End of Year 2010 which amount may be used for the payment of incentives of the District Health Personnel.

APPROPRIATION ORDINANCE NO. 2011-004
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FOR THE INCENTIVES OF THE DISTRICT HEALTH PERSONNEL ATTENDING MATERNAL DELIVERIES AFTER OFFICE HOURS AS PROVIDED FOR IN ORDINANCE NO. 159, OTHERWISE KNOWN AS THE "ORMOC CITY MATERNITY AND NEWBORN CARE ORDINANCE OF 2010" PARTICULARLY SECTION 10 THEREOF, AND ITS OPERATIONAL GUIDELINES AND IMPLEMENTING RULES AND REGULATIONS (IRR) TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2010.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FIVE HUNDRED THOUSAND PESOS (P500,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the incentives of the District Health Personnel attending maternal deliveries after office hours to be taken from out of the Unappropriated Surplus, End of Year 2010.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.






