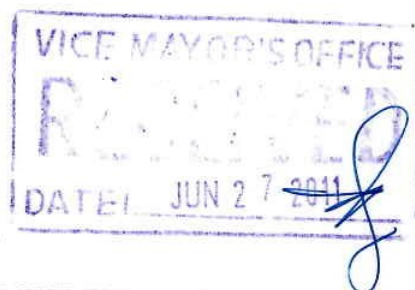

PREFATORY STATEMENT

PRESENTED to this august Body for consideration is an indorsement dated May 25, 2011 from the Office of the City Mayor relative to the request of Mr. Simon Albino O. Racaza, Supervising Administrative Officer, Ormoc City Superdome, for Reversion of Appropriation in the amount of THREE HUNDRED SEVENTY THOUSAND PESOS (P370,000.00) to supplement the appropriation for Maintenance and other Operating Expenses on Electricity – Public Building;

The City Budget Officer issued a Certification dated May 25, 2011 stating therein that funds are available for reversion from the Continuing Appropriation – FURNITURES & FIXTURES, CY 2010 to supplement ELECTRICITY – Public Building, an MOEE account of the Ormoc City Superdome;

The City Treasurer, through a Certificate of Availability of Funds dated May 25, 2011, certified that funds are available amounting to THREE HUNDRED SEVENTY THOUSAND PESOS (P370,000.00) from the Continuing Appropriation – FURNITURES & FIXTURES, CY 2010 which maybe used for reversion of appropriation to supplement the appropriation for Maintenance and Other Operating Expenses on ELECTRICITY – Public Building of same office;

FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Ruben C. Capahi, Chairman, Committee on Appropriation and Finance, jointly seconded by City Councilors Sotero M. Pepito and Corinne M. Corro; be it

APPROPRIATION ORDINANCE NO. 2011-009  
( General Fund )

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF THREE HUNDRED SEVENTY THOUSAND PESOS (P370,000.00) TO SUPPLEMENT THE APPROPRIATION FOR MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) ON ELECTRICITY – PUBLIC BUILDING OF THE ORMOC CITY SUPERDOME TO BE TAKEN FROM OUT OF THE REVERSION OF CONTINUING APPROPRIATION OF FURNITURES AND FIXTURES CY 2010 OF SAME OFFICE.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of THREE HUNDRED SEVENTY THOUSAND PESOS (P370,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to supplement the above-mentioned request of the Ormoc City Superdome to be taken from out of the reversion of Continuing Appropriation of Furnitures & Fixtures, CY 2010 of same office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, June 23, 2011.

CARRIED UNANIMOUSLY.




