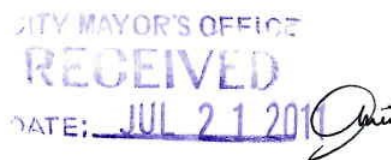

PREFATORY STATEMENT

PRESENTED to this august Body for consideration is an indorsement dated June 6, 2011 from the Office of the City Mayor relative to the request of Engr. Domardoni C. Cayanong, City General Services Officer and Vice Chairman, SWM-TWG, for an additional Appropriation in the amount of SIX MILLION PESOS (P 6,000,000.00) for the Integrated Solid Waste Management Program;

The City Budget Officer issued a Certification dated June 6, 2011 stating therein that funds amounting to SIX MILLION PESOS (P6,000,000.00) are available from out of the reversion of the Appropriation-Construction of New City Hall Building and LAN Structured Cabling Project, CY 2010 under the 20% Development Fund, which amount may be used as additional appropriation for Integrated Solid Waste Management Program;

The City Treasurer, through a Certificate of Availability of Funds dated June 6, 2011, certified that funds are available in the amount of SIX MILLION PESOS (P6,000,000.00) from out of reversion of Continuing Appropriation-Construction of New City Hall Building & LAN Structural Cabling Project, CY 2010 under the 20% Development Fund and the same may be used as a funding source for the Integrated Solid Waste Management Program of the City General Services Office;

APPROPRIATION ORDINANCE NO. 2011-011
(General Fund)

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF SIX MILLION PESOS (P6,000,000.00) TO BE TAKEN FROM OUT OF THE REVERSION OF CONTINUING APPROPRIATION-CONSTRUCTION OF NEW CITY HALL BUILDING AND LAN STRUCTURAL CABLING PROJECT, CY 2010 UNDER THE 20% DEVELOPMENT FUND WHICH MAY BE USED AS ADDITIONAL APPROPRIATION FOR THE INTEGRATED SOLID WASTE MANAGEMENT PROGRAM OF THE CITY GENERAL SERVICES OFFICE.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SIX MILLION PESOS (P6,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to supplement the above-mentioned request of the City General Services Office to be taken from out of the reversion of Continuing Appropriation-Construction of New City Hall Building & LAN Structural; Cabling Project, CY 2010.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.



ENACTED, July 14, 2011.






