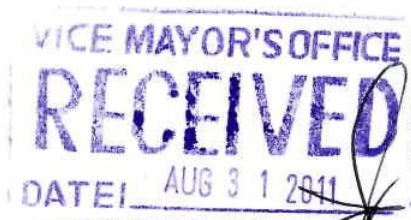

PREFATORY STATEMENT

PRESENTED to this august Body for consideration is an indorsement dated June 15, 2011 from the Office of the City Mayor relative to the request of Engr. Gervacio L. Germano, Jr., Waterworks Superintendent II, Ormoc Waterworks Division, for a Supplemental Appropriation in the amount of ONE MILLION FOUR HUNDRED THOUSAND PESOS (P 1,400,000.00), to supplement various MOOE accounts of the same office;

The City Budget Officer issued a Certification dated June 14, 2011 stating therein that funds amounting to ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00) are available from the Unappropriated Surplus, end of year 2010, for supplemental appropriation of ORWASA, broken down as follows:

Maintenance and Other Operating Expenses	
Chlorine Supplies	P1,200,000.00
Other Expenses	100,000.00
Repair & Maintenance-Motor Vehicles	100,000.00
Total	P1,400,000.00

The City Treasurer, through a Certificate of Availability of Funds dated June 14, 2011, certified that funds are available in the amount of ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00) from out of the Unappropriated Surplus, end of year 2010, which may be used as funding source for supplemental appropriation of ORWASA to fund the aforementioned purpose;

FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Jose C. Alfaro, Jr., Vice-Chairman, Committee on Appropriation and Finance, severally seconded by City Councilors Sotero M. Pepito, Rafael C. Omega, Jr. and Antonio M. Codilla; be it

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2011-012  
( General Fund )

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00) TO SUPPLEMENT THE VARIOUS MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) ACCOUNTS OF ORMOC WATERWORKS DIVISION (ORWASA) TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2010.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of ONE MILLION FOUR HUNDRED THOUSAND PESOS (P1,400,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the above-mentioned request of the Ormoc Waterworks Division to be taken from out of the Unappropriated Surplus, end of year 2010.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, August 25, 2011.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to his honor, the City Mayor Eric C. Codilla, the City Administrator, the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, the Ormoc Waterworks Division Superintendent: Engr. Gervacio L. Germano, Jr., and other offices concerned;




