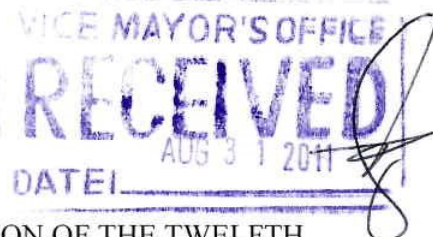

PREFATORY STATEMENT

PRESENTED to this august Body for consideration is an indorsement dated June 6, 2011 from the Office of the City Mayor relative to the request of Hon. Nepomuceno P. Aparis I, Vice-Mayor & Presiding Officer, for reversion of funds in the amount of ONE MILLION PESOS (P1,000,000.00) to be taken from the account – CY 2010 Capital Outlay – Motor Vehicles, to supplement the appropriation for Other Equipment of the Sangguniang Panlungsod;

The City Budget Officer issued an Indorsement dated August 16, 2011 reiterating that funding requirement for above purpose may be taken from out of the reversion of the continuing appropriation – Motor Vehicle CY 2010 of same office;

The City Treasurer, through a Certificate of Availability of Funds dated August 17, 2011, certified that funds are available in the amount of ONE MILLION PESOS (P1,000,000.00) from out of the Continuing Appropriation of the Sangguniang Panlungsod, as follows:

APPROPRIATION ORDINANCE NO. 2011-013  
( General Fund )

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) TO BE TAKEN FROM OUT OF THE REVERSION OF CONTINUING APPROPRIATION – CY 2010 CAPITAL OUTLAY – MOTOR VEHICLES OF THE SANGGUNIAN PANLUNGSOD TO SUPPLEMENT THE APPROPRIATION FOR CAPITAL OUTLAY – OTHER EQUIPMENT OF SAME OFFICE.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of ONE MILLION PESOS (P1,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to supplement the account Capital Outlay – Other Equipment of the Sangguniang Panlungsod to be taken from out of the reversion of Continuing Appropriation- CY 2010 Capital Outlay – Motor Vehicles of same office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.






