PREFATORY STATEMENT

PRESENTED to this august Body for consideration is an indorsement dated August 31, 2011 from the Office of the City Mayor in connection with the letter-request of OIC- City Engineer Ranulfo D. Oliveros, for a supplemental appropriation in the amount of TWENTY MILLION PESOS (P20,000,000.00) for the Construction and Upgrading/Repair of Socio-Cultural and Sports Development Facilities at various barangays within the City of Ormoc.

Anent the matter, the City Budget Officer issued a Certification dated August 26, 2011 certifying therein that the amount covered by the request is available from out of the Reversion of Continuing Appropriations under the 20% Development Fund and the same could be utilized for the Construction and Upgrading /Repair of Socio-Cultural Sports Development Facilities (Construction of Covered Courts) at the following barangays, to wit:

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2011-014  
(General Fund)

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00) FOR THE CONSTRUCTION AND UPGRADING/REPAIR OF SOCIO-CULTURAL FACILITIES (CONSTRUCTION OF COVERED COURTS) AT VARIOUS BARANGAYS WITHIN THE CITY OF ORMOC TO BE TAKEN FROM OUT OF REVERSION OF CONTINUING APPROPRIATIONS UNDER THE 20% DEVELOPMENT FUND.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWENTY MILLION PESOS (P20,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the Construction and Upgrading /Repair of Socio-Cultural Sports Development Facilities (Construction of Covered Courts) at various barangays within the city to be taken from out of reversion of Continuing Appropriations under the 20% Development Fund.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, September 29, 2011.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to His Honor, the City Mayor Eric C. Codilla; the City Administrator; the City Treasurer; the City Budget Officer; the City Accountant; the City Auditor; the City Engineer's Office; and others concerned.

WE HEREBY CERTIFY that the foregoing Appropriation Ordinance No. 2011-014 which approved the General Fund Supplemental Budget of Ormoc City for CY 2011 was duly enacted by the Twelfth Sangguniang Panlungsod ng Ormoc in its regular session.


