PREFATORY STATEMENT

PRESENTED to this august Body for consideration is a communication dated September 26, 2011 from the Office of the City Mayor urgently requesting for a Supplemental Appropriation in the amount of SIX MILLION PESOS (P 6,000,000.00), to purchase airconditioning units for the new Agri-Tech Building;

The City Budget Officer issued a Certification dated September 29, 2011 stating therein that the sum of SIX MILLION PESOS (P6,000,000.00) is available from the Unappropriated Surplus. End of Year 2010, to supplement the account — Office Equipment — of the City Mayor's Office, which amount may be used to purchase air-conditioning units for the new AgriTech Building:

The City Treasurer, through a Certificate of Availability of Funds dated September 29, 2011, certified that funds are available in the amount of SIX MILLION PESOS (P6,000,000.00) from out of the Unappropriated Surplus, End of Year 2010, which may be used to Supplement the Appropriation for Office Equipment of the Office of the City Mayor to fund the aforementioned purpose;

FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Ruben R. Capahi, Chairman, Committee on Appropriation and Finance, duly seconded by City Councilor Rafael C. Omega, Jr.; be it

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2011-015 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF SIX MILLION PESOS (P6,000,000.00) TO PURCHASE AIR-CONDITIONING UNITS FOR THE NEW AGRI – TECH BUILDING TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2010.



BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SIX MILLION PESOS (P6,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the above-mentioned request of the City Mayor's Office to be taken from out of the Unappropriated Surplus, End of Year 2010.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, October 13, 2011.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to His Honor, the City Mayor Eric C. Codilla, the City Administrator, the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, the City Agricultural Services Office (CASO) and other offices concerned;

CARRIED by Ten (10) Affirmative Votes Hon. Jose C. Alfaro, Jr. was out of the Session Hall during the voting.
