

PREFATORY STATEMENT

PRESENTED to this august Body for consideration is a communication dated September 2, 2011 from the Office of the City Mayor requesting for a Supplemental Appropriation in the amount of FOUR MILLION FIVE HUNDRED THOUSAND PESOS (P 4,500,000.00), for the purchase of various furnitures and fixtures and other equipment (agricultural/laboratory) for the new Agri-Tech Building:

The City Budget Officer issued a Certification dated September 2, 2011 stating therein that funds amounting to FOUR MILLION FIVE HUNDRED THOUSAND PESOS (P4,500,000.00) are available from the Unappropriated Surplus, End of Year 2010, to supplement the capital outlay appropriation of City Mayor's Office, broken down as follows:

The City Treasurer, through a Certificate of Availability of Funds dated September 02, 2011, certified that funds are available in the amount of FOUR MILLION FIVE HUNDRED THOUSAND PESOS (P4,500,000.00) from out of the Unappropriated Surplus, End of Year 2010, which may be used to Supplement the Appropriation on Capital Outlay of the Office of the City Mayor to fund the aforementioned purpose;

FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Ruben R. Capahi, Chairman, Committee on Appropriation and Finance, jointly seconded by City Councilors Sotero M. Pepito and Corinne M. Corro; be it

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2011-017 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR MILLION FIVE HUNDRED THOUSAND PESOS (P4,500,000.00) FOR THE PURCHASE OF VARIOUS FURNITURES AND FIXTURES AND OTHER EQUIPMENT (AGRICULTURAL/LABORATORY) FOR THE NEW AGRI-TECH BUILDING TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2010.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2011 GENERAL FUND SUPPLEMENTAL BUDGET</u>. The sum of FOUR MILLION FIVE HUNDRED THOUSAND PESOS (P4,500,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the above-mentioned request of the City Mayor's Office to be taken from out of the Unappropriated Surplus, End of Year 2010.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Monorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, October 13, 2011

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to His Honor, the City Mayor Eric C. Codilla, the City Administrator, the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor and other offices concerned;

CARRIED by Nine (9) Affirmative Votes with One (1) Abstention registered by Honorable Claudio P. Lavrazabal. Honorable Jose C. Alfaro, Jr. was out of the Session Hall during the voting.

WE HEREBY CERTIFY that the foregoing Appropriation Ordinance No. 2011-017 which approved the General Fund Supplemental Budget of Ormoc City for CY was duly exacted by the Twellth Sangguniang Panlungsod ng Ormoc in its regular session.
