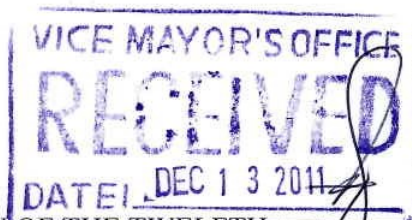
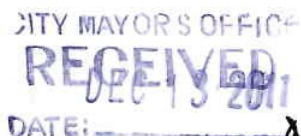

PREFATORY STATEMENT

PRESENTED to this august Body for consideration and appropriate action is a communication dated November 21, 2011 from the Office of the City Mayor requesting for a supplemental appropriation in the amount of SEVEN HUNDRED THIRTY FOUR THOUSAND SIX HUNDRED FIFTY FOUR PESOS & 59/100 (P734,654.59) for the following accounts under the City Mayor's Office:

1) Salaries & Wages - Casual	- P 373,818.49
2) PERA – Casual	- 142,208.70
3) Cash Gift – Casual	- 85,000.00
4) Year-End Bonus – Casual	- 97,609.00
5) Life & Ret. Ins. Contribution	- 36,018.40

TOTAL - P 734,654.59

Anent thereto, the City Budget Officer through a Certification dated November 22, 2011 certified that funds are available from the Salary Savings of Vacant Positions covering the period January 1 to October 31, 2011 amounting to P734,654.59 which amount may be used to supplement the appropriation for casual employees of the City Mayor's Office;

The City Treasurer through a Certificate of Availability of Funds dated November 23, 2011 also certified that the amount above requested are available to be taken from out of the Salary Savings of Vacant Positions for the period January 1, to October 31, 2011 and the same may be used to cover the requested supplemental appropriation by the City Mayor's Office;

AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVEN HUNDRED THIRTY FOUR THOUSAND SIX HUNDRED FIFTY FOUR PESOS & 59/100 (P734,654.59) TO SUPPLEMENT THE APPROPRIATION FOR CASUAL EMPLOYEES UNDER THE CITY MAYOR'S OFFICE BROKEN DOWN AS FOLLOWS:

1) SALARIES & WAGES - CASUAL	- P 373,818.49
2) PERA – CASUAL	- 142,208.70

TO BE TAKEN FROM OUT OF THE SALARY SAVINGS OF VACANT POSITIONS COVERING THE PERIOD JANUARY 1 TO OCTOBER 31, 2011.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SEVEN HUNDRED THIRTY FOUR THOUSAND SIX HUNDRED FIFTY FOUR PESOS & 59/100 (P734,654.59) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the appropriation for casual employees under the City Mayor's Office to be taken from out of the Salary Savings of Vacant Positions covering the period January 1 to October 31, 2011.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, December 05, 2011.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to His Honor, the City Mayor Eric C. Codilla; the City Administrator; the City Treasurer; the City Budget Officer; the City Accountant; the City Auditor; the Human Resource Management Office; and others concerned.




