BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TEN MILLION PESOS (P 10,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to supplement the above-mentioned projects of the City Engineers Office to be taken from out of the reversion of Continuing Appropriations under the 20% Development Fund of same office.



SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.




