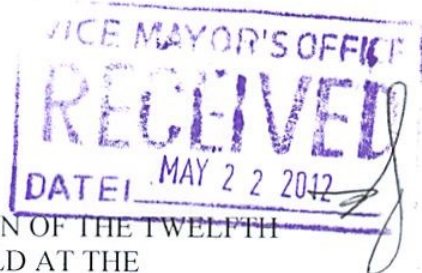
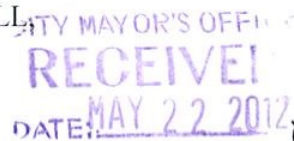

PREFATORY STATEMENT

PRESENTED to this Sanggunian for consideration is an indorsement dated April 25, 2012 from the Office of the City Mayor relative to the request of Engr. Gervacio L. Germano, Jr., Waterworks Superintendent II, Ormoc Waterworks Division for a supplemental appropriation in the amount of FORTY MILLION PESOS (P40,000,000.00) for the Rehabilitation/Improvement/Expansion of Ormoc Waterworks System (Phase III) covering various barangays in the City of Ormoc. The projects are among the priorities of the city hence, this request for supplemental appropriation to carry out its implementation.

In connection thereto, the City Budget Officer through a Certification dated April 25, 2012 certified that funds are available to cover the said request to be taken from the Unappropriated Surplus, End Year 2011.

The City Treasurer, through a Certificate of Availability of Funds dated April 25, 2012 also certified that the amount of FORTY MILLION PESOS (P40,000,000.00) are available from the Unappropriated Surplus, End of Year 2011 and the same may be used as a funding source for the Rehabilitation/Improvement/Expansion of Ormoc Waterworks System (Phase III) covering various barangays in the city as requested by Engr. Germano.

(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF FORTY MILLION PESOS (P40,000,000.00) TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011 TO FUND THE FOLLOWING PROJECTS, TO WIT:

REHABILITATION/IMPROVEMENT/EXPANSION OF ORMOC WATERWORKS SYSTEM (PHASE III):

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FORTY MILLION PESOS (P40,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to fund the abovementioned projects to be taken from out of the Unappropriated Surplus, End of Year 2011;

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval;

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

Codilla; the City Administrator; the City Treasurer; the City Budget Officer; the City Accountant; the City Auditor; the Ormoc Waterworks Division thru Engr. Gervacio L. Germano, Waterworks Superintendent II; and other offices concerned;


