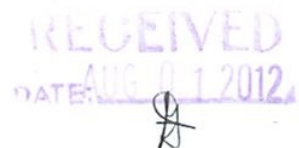

PREFATORY STATEMENT

PRESENTED to the Twelfth Sangguniang Panlungsod ng Ormoc for consideration is an indorsement dated July 11, 2012 from the Office of the City Mayor relative to the request of Mrs. Adelaida H. Biacolo, HRM Officer IV, for a supplemental appropriation in the amount of TWO HUNDRED TWENTY FOUR THOUSAND THREE HUNDRED FORTY NINE PESOS & 44/100 (P224,349.44) as appropriation for Terminal Leave Benefits of casual employees from various offices;

The City Budget Officer, through a certification dated July 10, 2012 certified that funds are available amounting to TWO HUNDRED TWENTY FOUR THOUSAND THREE HUNDRED FORTY NINE PESOS & 44/100 (P224,349.44) from the Unappropriated Surplus, end of year 2011, for the payment of terminal leave benefits of casual employees from various offices as requested by Mrs. A. Biacolo;

The City Treasurer through a Certificate of Availability of Funds dated July 11, 2012 also certified that funds are available in the amount of TWO HUNDRED TWENTY FOUR THOUSAND THREE HUNDRED FORTY NINE PESOS & 44/100 (P224,349.44) from the Unappropriated Surplus End of Year 2011, which may be made available as source of funds to supplement the appropriation for Terminal Leave Benefits - Casual employees of different offices, this City;

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWO HUNDRED TWENTY FOUR THOUSAND THREE HUNDRED FORTY NINE PESOS & 44/100 (P224,349.44) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to fund the above-mentioned request to be taken from out of the Unappropriated Surplus, End of Year 2011.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, July 30, 2012.


