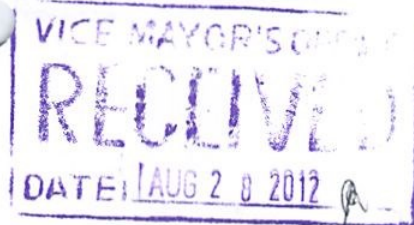
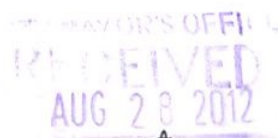

PREFATORY STATEMENT

PRESENTED to the Twelfth Sangguniang Panlungsod ng Ormoc for consideration is an Indorsement dated July 25, 2012 from the Office of the City Mayor relative to the request of Dr. Nelita D. Navales, City Health Officer II, for a Supplemental Appropriation in the amount of EIGHT MILLION EIGHT HUNDRED SIXTY TWO THOUSAND FIVE HUNDRED PESOS (P 8,862,500.00), to supplement the various MOOE accounts of the City Health Department;

The City Budget Officer issued a Certification dated July 25, 2012 stating therein that funds amounting to EIGHT MILLION EIGHT HUNDRED SIXTY TWO THOUSAND FIVE HUNDRED PESOS (P 8,862,500.00) are available from the Unappropriated Surplus, end of year 2011, to supplement the various MOOE accounts of the City Health Department;

The City Treasurer, through a Certificate of Availability of Funds dated July 25, 2012, certified that funds are available from the Unappropriated Surplus, end of year 2011 in the amount of EIGHT MILLION EIGHT HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED PESOS (P8,862,500.00), to supplement various MOOE accounts of the aforementioned office;

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Finance and Appropriations, jointly seconded by City Councilors Ruben R. Capahi and Corinne M. Corro; be it

APPROPRIATION ORDINANCE NO. 2012-018  
( General Fund )

AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHT MILLION EIGHT HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED PESOS (P8,862,500.00) TO SUPPLEMENT THE VARIOUS MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) ACCOUNTS OF THE CITY HEALTH DEPARTMENT TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011, BROKEN DOWN AS FOLLOWS:

FUEL, OIL & LUBRICANT EXPENSE	- P 500,000.00
ENVIRONMENT/SANITARY SERVICES	- 3,662,500.00
DRUGS AND MEDICINES	- 4,500,000.00

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of EIGHT MILLION EIGHT HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED PESOS (P8,862,500.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the above-mentioned request of the City Health Department to be taken from out of the Unappropriated Surplus, end of year 2011.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.






