PREFATORY STATEMENT

PRESENTED to this august Body for consideration is an urgent indorsement dated August 16, 2012 from the Office of the City Mayor relative to the request of Engr. Domardoni C. Cayanong, City General Services Officer, for a supplemental Appropriation in the amount of SEVEN MILLION TWO HUNDRED THOUSAND PESOS (P 7,200,000.00) to supplement the various MOOE accounts of the City General Services Office;

The City Budget Officer issued a Certification dated August 15, 2012 stating therein that funds are available from the Unappropriated Surplus, end of year 2011, amounting to SEVEN MILLION TWO HUNDRED THOUSAND PESOS (P 7,200,000.00) and the same maybe used to supplement the appropriation of the various MOOE accounts under the City General Services Office;

The City Treasurer, through a Certificate of Availability of Funds dated August 16, 2012 certified that funds are available from Unappropriated Surplus, end of year 2011 amounting to SEVEN MILLION TWO HUNDRED THOUSAND PESOS (P 7,200,000.00) as funding source for the requested supplemental appropriation;

AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVEN MILLION TWO HUNDRED THOUSAND PESOS (P 7,200,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011 TO SUPPLEMENT THE VARIOUS MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) ACCOUNTS OF THE CITY GENERAL SERVICES OFFICE, TO WIT:

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SEVEN MILLION TWO HUNDRED THOUSAND PESOS (P 7,200,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to fund the above-mentioned request of the City General Services Office to be taken from the Unappropriated Surplus, End of Year 2011.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;



ENACTED, August 30, 2012.
