The City Budget Officer, through a certification dated August 16, 2012 stated that funds are available from the Unappropriated Surplus, end of year 2011 amounting to THREE HUNDRED TEN THOUSAND PESOS (P310,000.00) as supplemental appropriation for Overtime and Night Pay of the City Treasurer's Office, in connection with the distribution of refund to electric consumers within Ormoc City;

The City Treasurer, through a Certificate of Availability of Funds dated August 16, 2012 certified that funds are available from the Unappropriated Surplus, end of year 2011 amounting to THREE HUNDRED TEN THOUSAND PESOS (P310,000.00), as funding source for the supplemental appropriation on Overtime and Night Pay of the said office in connection with the distribution of refund to electric consumers within Ormoc City;

## APPROPRIATION ORDINANCE NO. 2012-021 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE HUNDRED TEN THOUSAND PESOS (P310,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011 TO SUPPLEMENT THE APPROPRIATION FOR OVERTIME AND NIGHT PAY OF THE CITY TREASURER'S OFFICE, IN CONNECTION WITH THE DISTRIBUTION OF REFUND TO ELECTRIC CONSUMERS WITHIN ORMOC CITY.
