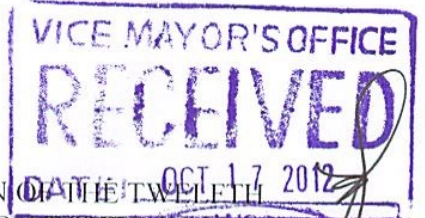

PREFATORY STATEMENT

PRESENTED to this sanggunian for consideration is an indorsement dated September 24, 2012 from the Office of the City Mayor covering the request of Mrs. Adelaida H. Biacolo, HRM Officer IV, for a supplemental appropriation in the amount of THREE MILLION THREE HUNDRED EIGHTY ONE THOUSAND PESOS (P3,381,000.00) for the grant of Anniversary Bonus to the officials and employees of the City Government of Ormoc on the occasion of the city's 65<sup>th</sup> Charter Day Celebration pursuant to Administrative Order No. 316 dated February 24, 1997 and DBM Local Budget Circular No. 65 dated March 3, 1997. The benefit is set at THREE THOUSAND PESOS (P3,000.00) for each city official and employee.

In connection thereto, the City Budget Officer issued a Certification dated September 24, 2012 certifying therein that the amount above requested is available to be taken from the Salary Savings of Vacant Positions covering the period January 1 to July 31, 2012.

The City Treasurer, through a Certificate of Availability of Funds dated September 24, 2012 also certified that funds amounting to THREE MILLION THREE HUNDRED EIGHTY ONE THOUSAND PESOS (P3,381,000.00) are available from the Salary Savings of Vacant Positions covering the period January 1 to July 31, 2012 and the same may be used as a funding source for the grant of Anniversary Bonus to the officials and employees of the City Government of Ormoc.

APPROPRIATION ORDINANCE NO. 2012-023  
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE MILLION THREE HUNDRED EIGHTY ONE THOUSAND PESOS (P3,381,000.00) FOR THE GRANT OF ANNIVERSARY BONUS TO THE OFFICIALS AND EMPLOYEES OF THE CITY GOVERNMENT OF ORMOC AT THREE THOUSAND PESOS (P3,000.00) FOR EACH OFFICIAL AND EMPLOYEE PURSUANT TO ADMINISTRATIVE ORDER NO. 316 DATED FEBRUARY 24, 1997 AND DBM LOCAL BUDGET CIRCULAR NO. 65 DATED MARCH 3, 1997, TO BE TAKEN FROM THE SALARY SAVINGS OF VACANT POSITIONS COVERING THE PERIOD JANUARY 1 TO JULY 31, 2012.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of THREE MILLION THREE HUNDRED EIGHTY ONE THOUSAND PESOS (P3,381,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to fund the Anniversary Bonus of the officials and employees of the City Government of Ormoc to be taken from the Salary Savings of Vacant Positions covering the period January 1 to July 31, 2012.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.





ENACTED, October 11, 2012.


