

PREFATORY STATEMENT

PRESENTED to the Twelfth Sangguniang Panlungsod ng Ormoc for consideration is an indorsement from the Honorable City Mayor Eric C. Codilla dated October 31, 2012 relative to the request of City Engineer Ranulfo D. Oliveros, for a supplemental appropriation in the amount of ELEVEN MILLION TWO HUNDRED THOUSAND PESOS (P11,200,000.00) for the implementation of the following projects, to wit:

1.) Establishment of Parks/Plazas and Recreational Facilities (Beautification of Parks & Plazas)	- P9,000,000.00
2. Construction/Upgrading of Public Buildings and Facilities (Re-painting of Public Market Bldg. A & B)	- 2,200,000.00

TOTAL	P11,200,000.00

In the same indorsement, it is further requested that the passage of the necessary appropriation ordinance be made on an urgent basis considering that the aforementioned projects which are subject for implementation are deemed priorities of the city.

In relation thereto, the City Budget Officer issued a Certification dated October 31, 2012 certifying therein that the sum of ELEVEN MILLION TWO HUNDRED THOUSAND PESOS (P11,200,000.00) is available for supplemental appropriation to fund the said projects which amount may be taken from the reversion of continuing appropriation as follows:

The City Treasurer, through a Certificate of Availability of Funds dated October 31, 2012 also certified that the funds above requested are available, to be taken from the reversion of Continuing Appropriation as enumerated above and the same may be used for the implementation of the said priority projects as requested by the City Engineer.

APPROPRIATION ORDINANCE NO. 2012-028  
(General Fund)

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF ELEVEN MILLION TWO HUNDRED THOUSAND PESOS (P11,200,000.00) TO BE TAKEN FROM OUT OF THE REVERSION OF CONTINUING APPROPRIATION TO FUND THE FOLLOWING PROJECTS, TO WIT:

1. ESTABLISHMENT OF PARKS/PLAZAS AND RECREATIONAL FACILITIES (BEAUTIFICATION OF PARKS & PLAZAS)	- P9,000,000.00
2. CONSTRUCTION/UPGRADING OF PUBLIC BUILDINGS AND FACILITIES (RE-PAINTING OF PUBLIC MARKET BLDG. A & B)	- 2,200,000.00
TOTAL	P11,200,000.00

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of ELEVEN MILLION TWO HUNDRED THOUSAND PESOS (P11,200,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the implementation of the aforementioned projects of the City Engineer's Office to be taken from out of the reversion of Continuing Appropriation.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, November 15, 2012.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to His Honor, the City Mayor Eric C. Codilla; the City Administrator; the City Treasurer; the City Budget Officer; the City Accountant; the City Auditor; the City Engineer's Office; and other offices concerned.




