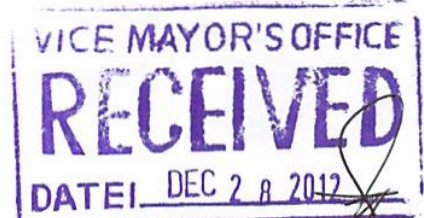

APPROPRIATION ORDINANCE NO. 2012-030
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE HUNDRED FIFTY THOUSAND PESOS (P 350,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011, TO SUPPLEMENT THE FOLLOWING PROGRAMS OF THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE, TO WIT:

PROVISION FOR THE OPERATION OF DAY CARE CENTERS – OTHER SERVICES	-	P158,500.00
PROVISION FOR THE OPERATION OF LINGAP CENTER – OTHER SERVICES	-	70,000.00
OTHER EXPENSES	-	<u>121,500.00</u>
TOTAL.....	-	P350,000.00

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of THREE HUNDRED FIFTY THOUSAND PESOS (P 350,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the above-mentioned request of the City Social Welfare & Development Office to be taken from Unappropriated Surplus, End of Year 2011.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, December 27, 2012
