PRESENTED to the Twelfth Sangguniang Panlungsod ng Ormoc for consideration is an Indorsement dated May 31, 2013 from the Office of the City Mayor relative to the request of Ms. Marietta S. Legaspi, City Social Welfare & Development Officer, for reversion of appropriation in the amount of TWO HUNDRED THOUSAND EIGHT HUNDRED SEVENTY FIVE PESOS (P200,875.00) to be taken from the Continuing Appropriation – Motor Vehicles CY 2011 of the City Social Welfare & Development Office, to supplement the following accounts of same office, to wit:

The City Budget Officer issued a Certification dated May 30, 2013 stating that funds amounting to TWO HUNDRED THOUSAND EIGHT HUNDRED SEVENTY FIVE PESOS (P200,875.00), from the Continuing Appropriation – Motor Vehicle CY 2011 of the City Social Welfare & Development Office, may be made available, thru reversion, to cover the said request;

The City Treasurer, through a Certificate of Availability of Funds dated May 31, 2013, certified that the sum of TWO HUNDRED THOUSAND EIGHT HUNDRED SEVENTY FIVE PESOS (P200,875.00), is available from Continuing Appropriation – Motor Vehicle CY 2011 of the City Social Welfare & Development Office which may be made available thru reversion of appropriation for the purchase of the abovementioned request;

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF TWO HUNDRED THOUSAND EIGHT HUNDRED SEVENTY FIVE PESOS (P 200,875.00) TO BE TAKEN FROM OUT OF THE CONTINUING APPROPRIATION – MOTOR VEHICLE CY 2011 OF THE CITY SOCIAL WELFARE & DEVELOPMENT OFFICE, WHICH MAY BE MADE AVAILABLE THRU REVERSION OF APPROPRIATION FOR THE PURCHASE OF THE FOLLOWING:

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2013 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWO HUNDRED THOUSAND EIGHT HUNDRED SEVENTY FIVE PESOS (P 200,875.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to supplement the above-mentioned request of the City Social Welfare & Development Office to be taken from out of the reversion of Continuing Appropriation – Motor Vehicle CY 2011 of same office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.






