PREFATORY STATEMENT

WHEREAS, presented to the Thirteenth Sangguniang Panlungsod ng Ormoc for consideration is an urgent Indorsement dated September 17, 2014 from the Office of the City Mayor relative to the request of Engr. Domardoni C. Cayanong, General Services Officer, for a resolution authorizing the purchase of one (1) unit buildozer in the amount of THIRTEEN MILLION TWO HUNDRED THOUSAND PESOS (P13,200,000.00), chargeable against reversion of current year's appropriation for Capital Outlay - Motor Vehicles of the City Mayor's Office to Capital Outlay -Construction and Heavy Equipment account of City General Services Office;

WHEREAS, the purchase of One (1) Unit Bulldozer is deemed important as it will be utilized in the day to day operation of the City's Sanitary Landfill specifically on the proper disposal and segregation of waste products;

WHEREAS, the City Budget Officer has issued a Certification dated September 16, 2014, stating that the funding source for the above mentioned request is available to be taken from out of reversion of Current Year's Appropriation by way of a Supplemental budget from the City Mayor's Office Capital Outlay - Motor Vehicles Account to the City General Services Office, Capital Outlay - Construction and Heavy Equipment Account;

WHEREAS, the City Treasurer, through a Certification of Availability of Funds, dated September 15, 2014, certified that the sum of THIRTEEN MILLION TWO HUNDRED THOUSAND PESOS (P13,200,000.00) is available under the current year's appropriation for Capital Outlay - Motor Vehicles of the City Mayor's Office, which may be used as source of funds through reversion of appropriation for the purchase of one (1) unit bulldozer.

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2014-008 (General Fund)

AN ORDINANCE REVERTING AND APPROPRIATING AMOUNT OF THIRTEEN **MILLION** TWO HUNDRED THOUSAND PESOS (P13,200,000.00) TO BE FROM CURRENT YEAR'S APPROPRIATION OUTLAY - MOTOR VEHICLES ACCOUNT OF THE CITY MAYOR'S OFFICE TO CAPITAL OUTLAY - CONSTRUCTION AND HEAVY EQUIPMENT ACCOUNT OF THE GENERAL SERVICES OFFICE FOR THE PURCHASE OF ONE (1) UNIT BRAND NEW BULLDOZER

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That;

SECTION 1. 2014 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of THIRTEEN MILLION TWO HUNDRED THOUSAND PESOS (P13,200,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the purchase of One (1) Unit Brand New Bulldozer to be taken from out of the reversion of Capital Outlay – Motor Vehicles Account of the City Mayor's Office to Capital Outlay - Construction and Heavy Equipment account of City General Services Office.

SECTION 2 <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval subject, however, to the compliance of the posting and publication requirements as provided for RA 7160, otherwise known as the Local Government Code of 1991

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all the supporting documents thereof, be submitted to the Honorable Secretary, Department of Budget & Management, Manila, Through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, October 02, 2014.

RESOLVED FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each, to the City Mayor, Hon. Edward C. Codilla; the City Administrator, the City Budget Officer; the City Accountant; the City Treasurer; the City Auditor; the City General Services Office; the City Director-DILG, Ms. Lucia C. Ong; and other offices concerned;
