PREFATORY STATEMENT

WHEREAS, presented to the 13th Sangguniang Panlungsod ng Ormoc for consideration is an Urgent Indorsement dated June 5, 2015 from the Honorable City Mayor Edward C. Codilla, requesting for a supplemental budget for the grant and payment of PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) to LGU Officials and Employees for CY 2015 chargeable against savings in current year's Personal Services (PS) allotment;

WHEREAS, in relation thereto, the Human Resource Management Officer (HRMO), Mrs. Adelaida H. Biacolo, submitted a computation of the total appropriation for the payment of PEI reflecting therein the total number of Employees who are qualified to receive such incentive which is equivalent to one (1) month basic salary of each official and employee who have rendered at least a total or an aggregate of four (4) months of service as of May 31, 2015 and obtained at least a satisfactory performance rating;

WHEREAS, as per computation by the HRMO, a total amount of FOURTEEN MILLION SIX HUNDRED FIVE THOUSAND ONE HUNDRED ELEVEN PESOS (P14,605,111.00) is needed for appropriation to cover said incentive broken down as follows:

WHEREAS, the City Budget Officer and the ICO – City Treasurer issued a Certification dated June 3, 2015, stating therein that funds are available for reversion from the savings of Current Year's Appropriations of Personal Services of different offices to fund the Productivity Enhancement Incentive (PEI) totalling to FOURTEEN MILLION SIX HUNDRED FIVE THOUSAND ONE HUNDRED ELEVEN PESOS (P14,605,111.00), copies of the Schedule of Personal Services from Vacant Positions for the period January 1 - May 31, 2015 are hereto attached and made an integral part hereof;

WHEREAS, the grant of PEI is in accordance with the Executive Order No. 181 dated May 5, 2015 issued by His Excellency, President Benigno S. Aquino III, which is in implementation of the provisions of the FY 2015 General Appropriations Act (GAA) on the grant of the FY 2015 Productivity Enhancement Incentive (PEI) to Government Employees;

WHEREAS, Item (4)(a)(iv) of the Senate and House of Representatives Joint Resolution (JR) No. 4 (s.2009) includes incentives as a component of the Total Compensation Framework for government personnel. Item (4)(h)(ii) thereof also provides for the grant of the Incentives as rewards for exceeding agency financial and operational performance targets, and to motivate employee efforts toward higher productivity;

WHEREAS, Section 4 (d.1) of Executive Order No. 181 stipulates that in the grant of PEI, the LGU's must be compliant with the requirements under the Good Financial Housekeeping (formerly the Seal of Good Housekeeping) component of the FY 2014 Seal of Good Local Governance (DILG Memorandum Circular No. 2014-39);

WHEREAS, LGU-ORMOC is one of the recipients of the Seal of Good Financial House Keeping, formerly known as Seal of Good Housekeeping (SGH) for CY 2014, as officially relayed by the DILG-City Director Ms. Lucia C. Ong through a communication dated May 5, 2015;

WHEREAS, covered by EO No. 181, are the civilian personnel occupying regular, contractual, or casual positions whether appointive or elective, on a full-time or part-time basis, provided they have an employer-employee relationship with the agencies concerned and whose compensation are charged against Personnel Services appropriations;

APPROPRIATION ORDINANCE NO. 2015-004

AN ORDINANCE APPROPRIATING THE AMOUNT OF FOURTEEN MILLION SIX HUNDRED FIVE THOUSAND ONE HUNDRED ELEVEN PESOS (P14,605,111.00) FOR THE GRANT OF THE PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) TO ORMOC CITY GOVERNMENT OFFICIALS AND EMPLOYEES FOR CY 2015, TO BE TAKEN FROM THE SAVINGS OF CURRENT YEAR'S PERSONAL SERVICES APPROPRIATIONS OF VARIOUS LGU OFFICES.

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2015 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FOURTEEN MILLION SIX HUNDRED FIVE THOUSAND ONE HUNDRED ELEVEN PESOS (P14,605,111.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the Productivity Enhancement Incentive (PEI) for FY 2015 of the officials and employees of LGU-Ormoc to be taken from the Current Year's Personal Services Savings of various LGU offices.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.



CARRIED UNANIMOUSLY.


