# PREFATORY STATEMENT

WHEREAS, presented to this august Body for consideration is an Indorsement dated August 4, 2015 from the Honorable City Mayor Edward C. Codilla, in relation to the request of Engr. Raoul E. Cam, City Planning and Development Coordinator, for a Supplemental Budget in the amount of TEN MILLION FIVE HUNDRED THOUSAND PESOS ONLY (R10,500,000.00), as LGU counterpart to the Bottom- Up Budgeting (RuB) funds for projects included in the FY 2015 Local Poverty Reduction Action Plan (LPRAP);

WHEREAS, the requested supplemental budget is LGU-Ormoc's cash counterpart for the implementation of the BuB Projects in Ormoc City as identified by LPRAT for FY 2015, which was approved by this Sanggunian through SP Resolution No. 2015-120 dated June 25,2015;

HEREAS, the City Budget Officer issued a Certification dated July 27, 2015, with the information that the amount of TEN MILLION FIVE HUNDRED THOUSAND PESOS (P10,500,000.00), to cover the requested LGU counterpart for the Bottom-Up Budgeting projects per SP Resolution No. 2015-120 is available, to be taken from the Unappropriated Surplus, end of year 2014;

WHEREAS, through a Certificate of Availability of Funds dated August 4, 2015, the ICO City Treasurer, certified that the amount above requested by the City Planning and Development Coordinator is available to be taken from the Unappropriated Surplus, end of year 2014, and the same may be used to cover the said request;

# APPROPRIATION ORDINANCE NO. 2015-008 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF TEN FIVE MILLION HUNDRED THOUSAND PESOS (P10,500,000.00) TO BETAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2014 AS LGU ORMOC COUNTERPART FOR THE BOTTOM BUDGETING (BUB) PROJECTS INCLUDED IN THE RY 2015 LOCAL POVERTY REDUCTION ACTION PLAN (LPRAP).

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2015 GENERAL FUND SUPPLEMENTAL BUDGET</u>. The sum of TEN MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P10,500,000.00), of the General Fund Supplemental Budget of Ormoc City is hereby appropriated as LGUs counterpart for the BuB Projects included in the FY 2015 LPRAP, to be taken from the Unappropriated Surplus, End of Year 2014.

SECTION 2. <u>CFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents thereof, be submitted to the Honorable Secretary, Department of Sudget & Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, August 27, 2015.
