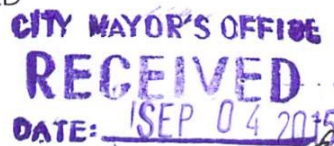

PREFATORY STATEMENT

WHEREAS, presented to the Thirteenth Sangguniang Panlungsod ng Ormoc for consideration is an urgent Indorsement dated August 17, 2015 from the Office of the City Mayor pertaining to the request of Engr. Ranulfo D. Oliveros, City Engineer, for an appropriation in the amount of THIRTY TWO MILLION FIFTY THOUSAND (P32,050,000.00) PESOS ONLY to be taken from the Unappropriated Surplus, end of Year 2014 for the purchase of Five (5) units 10-wheeler, 6 x 4 mounted with 10 cu.m. PHI Dump Truck Body and One (1) unit 3 cu.m. Wheel Loader under the account - Construction and Heavy Equipment of the City Engineer's Office;

WHEREAS, this request is in lieu of a previous request dated March 19, 2015 for the purchase of Four (4) units 6x4 Heavy Duty 12m3 Ribless Dumper and One (1) unit Payloader by the same office in the amount THIRTY FIVE MILLION ONE HUNDRED THOUSAND PESOS (P35,100,000.00);

WHEREAS, the purchase of the aforementioned heavy equipment is necessary and deemed very important for the improvement of day to day operation and efficient implementation of various projects undertaken by the City Engineering Office;

WHEREAS, the City Budget Officer issued a Certification dated August 25, 2015 indicating that the amount of THIRTY TWO MILLION FIFTY THOUSAND PESOS (P32,050,000.00), intended for the purchase of Five (5) units 10 wheeler 6x4 mounted with 10 cu.m. PHI Dump Truck Body and One (1) unit Wheel Loader, under the account - Construction & Heavy Equipment of the City Engineer's Office, is available to be taken from the Unappropriated Surplus, end of Year 2014;

WHEREAS, through a Certificate of Availability of Funds dated August 25, 2015, the ICO City Treasurer certified that the above requested funds are available, to be taken from the Unappropriated Surplus, end of Year 2014 and the same may be used to cover the said request of the City Engineering Office for the aforementioned purposes;

RESOLVED, to enact:

*APPROPRIATION ORDINANCE NO. 2015-009
(General Fund)*

AN ORDINANCE APPROPRIATING THE AMOUNT OF THIRTY-TWO MILLION FIFTY THOUSAND PESOS (P32,050,000.00) FOR THE PURCHASE OF FIVE (5) UNITS 10- WHEELER, 6 X 4 MOUNTED WITH 10 CU.M. PHI DUMP TRUCK BODY AND ONE (1) UNIT 3 CU.M. WHEEL LOADER UNDER THE ACCOUNT - CONSTRUCTION AND HEAVY EQUIPMENT OF THE CITY ENGINEER'S OFFICE, , TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2014.

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2015 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of THIRTY-TWO MILLION FIFTY THOUSAND PESOS (P32,050,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the purchase of five (5) units 10- wheeler 6x4 mounted with 10 cu.m. PHI dump truck body and one (1) unit 3 cu.m. wheel loader under the account-Construction & Heavy Equipment of the City Engineer's Office, to be taken the Unappropriated Surplus, end of year 2014.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, August 27, 2015.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance one each to His Honor, the City Mayor Edward C. Codilla; the City Administrator; the City Legal Officer ; the City Engineer, Engr. Ranulfo D. Oliveros; the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, the City Director-DILG, Ms. Lucia C. Ong and other offices concerned;
