SECTION 1. 2015 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FIFTY THREE MILLION TWO HUNDRED FIFTY FIVE THOUSAND PESOS (P53,255,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the implementation of various projects in different barangays of the city to be taken from the Reversion of Continuing Appropriation of the General Fund and 20% Development Fund as per attached Schedules.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FORTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
