## PREFATORY STATEMENT

VHEREAS, presented to this august Body for consideration is an Urgent Indersement dated September 30, 2015 from the Office of the City Mayor pertaining to the request of Engr. Raoul E. Cam, City Planning & Development Coordinator, for a supplemental budget in the amount of THIRTEEN MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P13,500,000.00) to be taken from the Unappropriated Surplus, end of year 2014 for the purchase/installation of CCTV Monitoring cameras as requested by the City Disaster Risk Reduction Management Office (CDRRMO) and purchase of motor vehicles for Ormoc City Police Office (OCPO) use;

WHEREAS, the proposed purchase and installation of CCTV Monitoring Cameras is already included in the approved City Recovery and Rehabilitation Plan for Typhoon Yolanda damages as manifested by Mr. Ciriaco E. Tolibao, CDRRM Officer Designate thus, the need to be funded for it is deemed essential and effective in facilitating immediate responses to incidents, deterring crimes and ensuring public safety in Ormoc City;

WHEREAS, the purchase of the motor vehicles (2 units 4x4 pick-up trucks, 2 units AUVs, 4 units multi-cab) and other necessary equipment for OCPO would help enhance their capability in the delivery of public safety services particularly in crime prevention, law enforcement, as well as to provide better quality services to Ormocanons;

WHEREAS, the City Budget Officer issued a Certification dated September 21, 2015, with the information that the amount of THIRTEEN MILLION FIVE HUNDRED THOUSAND PESOS (P13,500,000.00) is available to be taken from the Unappropriated Surplus, end of year 2014, for the aforementioned purposes under the following object of expenditures of the Office of the City Mayor to wit:

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.
