PREFATORY STATEMENT

WHEREAS, presented to the Thirteenth Sangguniang Panlungsod ng Ormoc for consideration is an urgent Indorsement dated November 12, 2015 from the Office of the City Mayor pertaining to the request of the Honorable City Vice Mayor & Presiding Officer, Leo Carmelo L. Locsin Jr., for reversion of funds to supplement the account Motor Vehicles-Capital Outlay in the amount of TWO HUNDRED FOUR THOUSAND SIX HUNDRED PESOS ONLY (P204,600.00) to be taken from the account-Furnitures & Fixtures, CY 2011 of the Sangguniang Panlungsod for the purchase of service vehicle;

WHEREAS, the requested supplemental budget thru reversion is an additional appropriation to carry out the intention of Sangguniang Panlungsod to procure a service vehicle for the improvement of its day to day operation;

WHEREAS, to recall, this Sanggunian had earlier passed a supplemental appropriation under Appropriation Ordinance No. 2015-011 enacted on October 01, 2015 in the amount of ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00) which purpose is for the procurement of service vehicle for the Sangguniang Panlungsod. However, the amount is insufficient to fund the cost of the vehicle to be procured hence, the need to have an additional appropriation;

WHEREAS, the City Budget Officer issued a Certification dated November 12, 2015, stating that the funds being requested amounting to TWO HUNDRED FOUR THOUSAND SIX HUNDRED PESOS ONLY (P204,600.00), which may be taken from out of reversion of continuing appropriation - Furnitures and Fixtures, CY 2011, is available for the purchase of Motor Vehicles of Sangguniang Panlungsod;

WHEREAS, the City Treasurer, through a Certificate of Availability of Funds dated November 12, 2015 certified that funds are available to cover the said request of Vice Mayor Leo Carmelo L. Locsin Jr., to be taken from the reversion of Continuing Appropriation of the aforementioned account of the Sangguniang Panlungsod;

APPROPRIATION ORDINANCE NO. 2015-019  
(General Fund)

*AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF TWO HUNDRED FOUR THOUSAND SIX HUNDRED PESOS ONLY (P204,600.00) TO BE TAKEN FROM OUT OF THE REVERSION OF CONTINUING APPROPRIATION - FURNITURES AND FIXTURES, CY 2011 OF THE SANGGUNIANG PANLUNGSOD, FOR THE PURCHASE OF MOTOR VEHICLE.*

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2015 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWO HUNDRED FOUR THOUSAND SIX HUNDRED PESOS ONLY (P204,600.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the purchase of motor vehicle for Sangguniang Panlungsod to be taken from out of the reversion of the Continuing Appropriation - Furnitures & Fixtures, CY 2011 of same office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, November 19, 2015.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance one each to His Honor, the City Mayor Edward C. Codilla; the City Administrator; the City Legal Officer; the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, the City Director-DILG, Ms. Lucia C. Ong and other offices concerned;
