PREFATORY STATEMENT

WHEREAS, presented to this august Body for consideration is an Indorsement dated November 20, 2015 from the Office of the City Mayor regarding the request of Engr. Gervacio L. Germano Jr., Waterworks Superintendent II, for reversion of funds to be taken from the account – 2012 S/Sangi, B/Ipil (Production Well) in the amount of FIVE HUNDRED FORTY TWO THOUSAND EIGHT HUNDRED SEVENTY SEVEN PESOS & 61/100 ONLY (P542,877.61);

WHEREAS, the request for reversion of funds was made due to the need of purchasing materials for the Installation of Pipelines at various Barangays within the city in line with the commitment of Ormoc Waterworks Division to continuously develop the water supply system for the benefit of the people especially those living in the Barangays where water supply is scarce;

WHEREAS, the City Budget Officer issued a Certification dated November 18, 2015 stating that the amount of FIVE HUNDRED FORTY TWO THOUSAND EIGHT HUNDRED SEVENTY SEVEN PESOS & 61/100 ONLY (P542,877.61), which may be taken from the reversion of the account – 2012 S/Sangi, B/Ipil (Production Well), is available for the Installation of Pipelines at various Barangays, this City;

WHEREAS, the City Treasurer, through a Certificate of Availability of Funds dated November 18, 2015 likewise certified that the funds covered by the request are available thru the reversion of the account – 2012 S/Sangi, B/Ipil (Production Well) of the Ormoc Waterworks Division which amount may be used for the installation of pipelines at various barangays;

*APPROPRIATION ORDINANCE NO. 2015-020
(General Fund)*

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF FIVE HUNDRED FORTY TWO THOUSAND EIGHT HUNDRED SEVENTY SEVEN PESOS & 61/100 ONLY (P542,877.61) TO BE TAKEN FROM OUT OF THE REVERSION OF THE ACCOUNT – 2012 S/SANGI, B/IPIL (PRODUCTION WELL) OF THE ORMOC WATERWORKS DIVISION FOR THE INSTALLATION OF PIPELINES AT VARIOUS BARANGAYS IN ORMOC CITY.

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2015 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FIVE HUNDRED FORTY TWO THOUSAND EIGHT HUNDRED SEVENTY SEVEN PESOS & 61/100 ONLY (P542,877.61) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the installation of pipelines at various barangays in the city to be taken from out of the reversion of the account – 2012 S/Sangi, B/Ipil (Production Well) – of the Ormoc Waterworks Division.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


